

## **Extent**

Approximately 2,388 photographs in color and black & white film processed from 35mm negatives.

## **Summary**

The photographs processed in this segment were created from March 26, 1994 through April 2, 1994. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff and others for the time period processed.

## **Scope and Content Note**

FOIA 2016-0984-F (Segment 28) is a request for all Clinton Administration White House photographs taken from January 1, 1994 through December 31, 1994. The photographs processed in this segment were created from March 26, 1994 through April 2, 1994. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff and others for the time period processed. Many images in this case were processed in previous FOIA cases, including case # 2016-0871-F, case # 2016-0836-F, and case # 2021-0263-F. Additionally this segment includes two rolls that the White House Photograph Office transferred to the White House Curator's Office containing Easter decorations & two rolls pulled from the staff series files that were found to be responsive. Photographs from March 26, 1994 are as follows: President William Jefferson Clinton golfs at Prestonwood Country Club in Dallas, Texas. Photographs from March 27, 1994 are as follows: President William Jefferson Clinton jogs near Turtle Creek Boulevard in Dallas, Texas President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Chelsea Clinton are photographed outside of First Baptist Church in Dallas, Texas. Also photographed is Reverend Brian Harbour.

Photographs from March 28, 1994 are as follows: President William Jefferson Clinton jogs on Coronado Beach in Coronado, California. First Lady Hillary Rodham Clinton, Chelsea Clinton, and Elizabeth Fleming ride bikes. Photographs from March 29, 1994 are as follows: President William Jefferson Clinton jogs on Coronado Beach in Coronado, California. President William Jefferson Clinton golfs at the Sea and Air Golf Course at the North Island Naval Air Station in Coronado, California. Actors Martin Short and Nancy Dolman Short visit the White House. Also photographed includes Melinda Bates and Kelly Crawford. Miscellaneous material photographed includes Socks the cat photographed at the White House in various rooms, Dr. John Daly participates in a personnel seminar at Jackson Place in Washington, DC, Loretta Avent meets with American Indian Tribe representatives at the White House, and staff portraits of Patricia Codgewell & Steve Kelman. Photographs from March 31, 1994 are as follows: President William Jefferson Clinton signs the Goals 2000 Educate America Act in San Diego, California. Present includes First Lady Hillary Rodham Clinton, Secretary of Education Richard Riley, and Representative Lynn Schenk, among others. President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Chelsea Clinton visit the San Diego Wild Animal Park in California. President William Jefferson Clinton visits the Old Town Mexico Café in San Diego, California. Assistant Chef John Moeller dyes eggs for the White House Easter Egg Roll event. Photographs from April 1, 1994 are as follows: President William Jefferson Clinton golfs at the Coronado Municipal Golf Course in Coronado, California. Later, the President and

First Lady Hillary Rodham Clinton ride bicycles on Orange Avenue in Coronado. Socks the cat poses with Easter eggs. Also photographed is Wayne Skinner. Photographs from April 2, 1994 are as follows: President William Jefferson Clinton golfs at the Sea and Air Golf Course at the North Island Naval Air Station in Coronado, California. President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Chelsea Clinton depart Coronado, California. The President, First Lady, and Chelsea proceed to the Naval Air Station in Coronado for departure.

## **System of Arrangement**

Records that were responsive to this FOIA request were found in one collection area and one series— Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
