Approximately 50 photographs in color and black & white film processed from 35mm negatives and 1 video recording on betacam format approximately 23 minutes & 59 seconds in length.

Summary

FOIA 2023-0541-F is a request for all audio/visual records relating to former President Richard Milhous Nixon greeting President William Jefferson Clinton at the White House on March 8, 1993. Additional events processed include meeting with the House Budget Committee in the Cabinet Room and meeting with the Congressional Black Caucus in the Roosevelt Room. Additional material processed as consequence includes meeting with Democratic leaders in the Family Dining Room and the arrival of President François Marie Adrien Maurice Mitterrand of France to the White House on March 9, 1993.

Scope and Content Note

FOIA 2023-0541-F is a request for all audio/visual records relating to former President Richard Milhous Nixon greeting President William Jefferson Clinton at the White House on March 8, 1993. Additional events processed include meeting with the House Budget Committee in the Cabinet Room and meeting with the Congressional Black Caucus in the Roosevelt Room. System of Arrangement

Records that were responsive to this FOIA request were found in two collection areas and two series— Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration, and Video Recordings of the White House Photograph Office and the series therein—Video Recordings Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level and individual recorded tape level. While this method maintains folder/contact sheet integrity and tape run time, it frequently results in the processing of photographs and video recordings that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
