Approximately 634 photographs in color and black & white film processed from 35mm negatives.

Summary

The photographs processed in this segment were created from April 16, 1994; April 20, 1994, through April 22, 1994. All the photo contact sheets reviewed in this segment are from dates April 22, 1994, and April 23, 1994. Many photo contact sheets in this segment were previously processed in cases: 2015-0709-F, 2019-0865-F, 2022-0194-F, and 2022-0195-F. The Finding Aid inventory will reflect the previously processed photo contact sheets. The segment consists of photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Scope and Content Note

FOIA 2016-0984-F (Segment 37) is a request for all Clinton Administration White House photographs taken April 16, 1994; April 20, 1994, through April 22, 1994. All the photo contact sheets reviewed in this segment are from dates April 22, 1994, and April 23, 1994. The majority of photo contact sheets in this segment were previously processed in cases: 2015-0709-F, 2019-0865-F, 2022-0194-F, and 2022-0195-F. The Finding Aid inventory will reflect the previously processed photo contact sheets. The photographs processed in this segment contains photographic events pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed. Photographs from April 22, 1994, are as follows: First Lady Hillary Rodham Clinton greets and has tea with Dimitra Liani-Papandreou of Greece and her friend Effie Weinberg in the Diplomatic Reception Room. President Clinton talks on the

telephone in the Oval Office to Pope John Paul II. Vice President Albert Gore and Nancy Soderberg are present for the telephone call. President Clinton meets in the Oval Office with Attorney General Janet Reno, Mack McLarty, George Stephanopoulos, Pat Griffin, Ron Klain, Rahm Emanuel, Bruce Reed, and others regarding a meeting with members of Congress related to crime. President Clinton meets in the Cabinet Room with members of Congress regarding crime. Meet participants include Attorney General Janet Reno, Senator Joe Biden, Senator George Mitchell, Representative Tom Foley, Representative Jack Brooks, Representative Charles Schumer, Representative David Bonior, Mack McLarty, Bruce Reed, Pat Griffin, Ron Klain, and others. President Clinton talks alone with Senator Biden. President Clinton greets B.A. Bentsen and March of Dimes children and their families in the Oval Office. President Clinton greets Library Week representatives in the Oval Office. A young girl presents the President with a t-shirt that reads "Libraries Change Lives (They Changed Mine)." President Clinton talks on the telephone in the Oval Office to Prime Minister Jean Chretien of Canada. President Clinton meets in the Oval Office with Robert Rubin, Michael Froman, Paul Toback, and Nancy Soderberg. The President looks at a booklet entitled "Catalogue of Hope Crime Prevention Programs for At-Risk Children." President Clinton confers in the Oval Office with Secretary Warren Christopher, Vice President Albert Gore, Sandy Berger, Dee Dee Myers, Mark Gearan, Jane Holl, Jenonne Walker, and others. Photographs from April 22, 1994, Continued: Prime Minister Andreas Papandreou of Greece signs the guest book in the Roosevelt Room with Molly Raiser. President Clinton meets with Prime Minister Papandreou in the Oval Office. Meeting participants include Vice President Albert Gore, Secretary Warren Christopher, Sandy Berger, and others. The Press Pool covers the meeting. President Clinton and Prime Minister Papandreou look at the White House Rose Garden and White House from the Colonnade. First Lady Hillary Rodham Clinton greets John Flake and Karen Flake in the Diplomatic Reception Room. First Lady Hillary Rodham Clinton greets Dorothy Davis and Carolyn Huber in the Map Room. First Lady Hillary Rodham Clinton walks with David Neslen, Advance staff, in Washington, D.C. The First Lady arrives at Keystone Communications Studio to record a video for Mary Steenburgen and to participate in a satellite feed to the Children's Miracle Network 1994 Convention. First Lady Hillary Rodham Clinton greets interns in the Diplomatic Reception Room. President Clinton walks along the Colonnade with George Stephanopoulos following the President's morning jog. President Clinton greets and participates in a photo with a group from Arkansas in the Rose Garden. Mack McLarty greets an intern in his West Wing office. President

Clinton tapes his weekly radio address in the Roosevelt Room. President Clinton and Eli Segal address the National Volunteer Action Awards Ceremony in the Rose Garden. President Clinton greets ceremony guests including Edward James Olmos and others. Photographs from April 23, 1994, are as follows: President Clinton participates in a meeting in the White House Situation Room regarding Bosnia. Meeting participants include Vice President Albert Gore, Secretary Warren Christopher, Secretary William Perry, General John Shalikashvili, Director James Woolsey, Tony Lake, Ambassador Madeleine Albright, and others.

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
