Approximately 235 photographs in color film processed from 35mm negatives.

Summary

The photographs processed in this case consist of President Clinton and First Lady Hillary Rodham visiting White Oak Plantation in Yulee, Florida on May 25, 27, 29, and 30, 1999. President Clinton makes remarks to the press at White Oak Plantation regarding President Slobodan Milosevic, President Clinton plays golf at White Oak Plantation, and President Clinton and First Lady Hillary Rodham Clinton greet people at White Oak Plantation during their visit and during their departure from Florida.

Scope and Content Note

President Clinton and First Lady Hillary Clinton visited White Oak Plantation in Yulee, Florida in May 1999. This case includes the following photographic events regarding their visit to White Oak Plantation. President Clinton arrives and greets people at White Oak Plantation Aviation on May 25, 1999. President Clinton delivers remarks to reporters at White Oak Plantation regarding the International War Crimes Tribunal decision to indict President Slobodan Milosevic of Serbia & Montenegro on May 27, 1999. President Clinton plays golf with Paul Tesoori, Chad Reynolds, and Alfred Checchi at White Oak Plantation on May 29, 1999. President Clinton greets people at the White Oak Plantation following his round of golf. President Clinton with First Lady Hillary Rodham Clinton greet White Oak Plantation personnel, police, and other prior to their departure from White Oak Plantation on May 30, 1999.

Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
