Summary

The photographs processed in this case consist of President Clinton, First Lady Hillary Rodham, and Chelsea Clinton, and members of a U.S. delegation attending funeral services for King Hassan II of Morocco on July 25, 1999 in Rabat, Morocco. Dignitaries present include former President George H.W. Bush, former Secretary of State James A. Baker, former Secretary of State Warren Christopher, Prime Minister Ehud Barak of Israel, Chairman Yasser Arafat of the Palestinian Authority, King Juan Carlos of Spain, Prince Charles of the United Kingdom, and others.

Scope and Content Note

President Clinton, First Lady Hillary Rodham Clinton, Chelsea Clinton, and members of a U.S. delegation attend funeral services in Rabat, Morocco for King Hassan II on July 25, 1999. Photographs include overall shots of the funeral procession from the Royal Palace to the Mausoleum. The procession includes photos of King Hassan's draped casket being carried to the Mausoleum. The Clintons talk with guests at the funeral service. Dignitaries present include former President George H.W. Bush, former Secretary of State James A. Baker, former Secretary of State Warren Christopher, Prime Minister Ehud Barak of Israel, Chairman Yasser Arafat of the Palestinian Authority, King Juan Carlos of Spain, Prince Charles of the United Kingdom, and others.

Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
