Summary

The segment consists of photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Scope and Content Note

FOIA 2016-0984-F (Segment 88) is a request for all Clinton Administration White House photographs taken September 21, 1994, through September 24, 1994. The Clinton Presidential records to be opened consist of photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, official phone calls, photo-ops, etc. involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed. Photographs from September 21, 1994, are as follows: President Clinton greets Norman Lear in the Oval Office. President Clinton signs S. 1357 "Little Traverse Bay Bands of Odawa Indians and the Little River Band of Ottawa Indians Act" and S. 1066 "Pokagon Band of Potawatomi Indians Recognition Act" in the Oval Office. Signing ceremony participants include Senator Don Riegle, Representative Bill Richardson, Senator Carl Levin. A group of Native Americans are present at the signing. Paul Richard arranges documents and pens for the signing ceremony. President greets a group of visitors from Arkansas in the Oval Office. First Lady Hillary Rodham Clinton meets with Ann Stock, Capricia Marshall, Nancy Olson, Melanne Verveer, and Rex Scouten regarding table settings and other matters in the China Room. Socks the cat lays on Betty Currie's desk with Debi Schiff and Betty Currie present in the Outer Oval Office. President Clinton and First Lady Hillary Rodham Clinton meet and greet Meryl Streep and her family in the Cabinet Room and Oval Office. President Clinton

greet representatives from the Boys and Girls Clubs of America in the Oval Office. President Clinton poses for a group photo with participants. President Clinton meets in the Oval Office with Representative Bernard "Bernie" Sanders. President Clinton meets with Vice President Albert Gore, Sandy Berger, and others in the Oval Office. President Clinton participates in a National Security Council meeting in the Cabinet Room. Meeting participants include Secretary Lloyd Bentsen, Secretary William Perry, Leon Fuerth, Bowman Cutter, Tony Lake, Rose Gottemoeller, and others. President Clinton addresses a meeting of Union officials at the Hay Adams Hotel in Washington, DC. President Clinton, First Lady Hillary Rodham Clinton, and Dr. John Brademas, Chairman of the Presidential Commission on the Arts and Humanities, address the Commission on the Arts and Humanities ceremony in the East Room. The Clintons greet ceremony guests in the Blue Room. Guests include Senator Howard Metzenbaum, Senator Patrick Leahy, Quincy Jones, Jane Alexander, J. Carter Brown, Secretary Richard Riley, Rita Moreno, Isaac Stern, and others. Photographs from September 21, 1994, Continued: President Clinton talks with Lorraine Miller in the Oval Office. President Clinton arrives at the Sheraton Washington Hotel for the Democratic Senate Campaign Committee Fall event. President Clinton addresses the committee. President Clinton meets with Marcia Hale in the Oval Office. Photographs from September 22, 1994, are as follows: First Lady Hillary Rodham Clinton greets representatives from the White House Historical Society in the Map Room. First Lady Hillary Rodham Clinton greets recording artist Michael Bolton in the West Wing. President Clinton and First Lady Hillary Rodham Clinton greet guests in the Blue Room prior to the Rhythm & Blues Dinner and Concert in the East Room and South Lawn. The President greets performers Michael Bolton and The Pointer Sisters in the Oval Office. Andrew Friendly and Kelly Crawford joke together in the Outer Oval Office. President Clinton meets in the Oval Office with Leon Panetta and Phil Lader. President Clinton meets in the Oval Office with Prime Minister Eddie Fenech Adami of Malta. President Clinton signs a proclamation with Italian American White House staff present. Signing participants include Laura D'Andrea Tyson, Leon Panetta, Steve Ricchetti, John Podesta, Pat Griffin, Phil Lader, and others. Photographs from September 23, 1994, are as follows: President Clinton participates in a Community Development Bill signing ceremony in the Thomas Jefferson Auditorium at the U.S. Department of Agriculture in Washington. Ceremony participants include Secretary Lloyd Bentsen, Secretary Mike Espy, Small Business Administrator Erskine Bowles, and others. Photographs from September 23, 1994, Continued: President Clinton meets with Secretary Lloyd Bentsen, Carter Wilkie, and Treasury Department staff at

the U.S. Department of Treasury in Washington. Secretary Bentsen talks alone with Leon Panetta. President Clinton greets Debi Schiff and her mother in the Outer Oval Office. President Clinton meets with Senator Daniel Moynihan and Senator Robert Packwood in the Oval Office. First Lady Hillary Rodham Clinton meets in the Diplomatic Reception Room with Patricia Kreiner, Mayor of Cape Town, South Africa. Leon Panetta delivers a press briefing in the Press Briefing Room regarding staff changes. First Lady Hillary Rodham Clinton arrives at Logan International Airport in Boston, Massachusetts. The First Lady greets Park Plaza Hotel personnel and others in Boston. First Lady Hillary Rodham Clinton greets Walter Kaye and friends at the Park Plaza Hotel in Boston. The First Lady greets former Wellesley College classmates at the Park Plaza Hotel. First Lady Hillary Rodham Clinton visits Children's Hospital with Senator Edward "Ted" Kennedy in Boston. The First Lady visits children at an activity table in the activities room at the hospital. The First Lady and Senator Kennedy deliver remarks to hospital staff. First Lady Hillary Rodham Clinton greets firefighters, police, and others at Logan International in Boston prior to departing for a flight to Andrews Air Force Base. Photographs from September 24, 1994, are as follows: First Lady Hillary Rodham visits the U.S. Coast Guard Academy in New London, Connecticut. The First Lady greets directors and others at the academy. First Lady and Chelsea Clinton visit the Electric Boat company in Groton, Connecticut. The First Lady makes remarks in the shipyard to families of the crew of the Columbia SSN 771. The First Lady talks to Senator Chris Dodd and greets company officials and personnel. Photographs from September 24, 1994, Continued: First Lady Hillary Rodham Clinton greets police personnel and others prior to departing New London for a flight to New York City.

Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
