Summary

The photographs processed in this segment were created on September 23, 1994 through September 25, 1994. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Scope and Content Note

FOIA 2016-0984-F (Segment 89) is a request for all Clinton Administration White House photographs taken from January 1, 1994 through December 31, 1994. The photographs processed in this segment were created on September 23, 1994 through September 25, 1994. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed. Photographs responsive to this segment were previously processed in FOIA case number 2022-0200-F. Photographs from September 23, 1994 are as follows: President William Jefferson Clinton departs the White House Reflecting Pool en route Chicago, Illinois. The President converses with staff aboard Air Force One during the trip including Kevin O'Keefe, Joan Baggett, Josh King, Harold Ickes, and Wendy Smith. The President is photographed in separate instances arriving at Chicago O'Hare International Airport aboard Air Force One and Meigs Field aboard Marine One in Chicago, Illinois. Photographs from September 24, 1994 are as follows: President William Jefferson Clinton jogs in Chicago, Illinois. The President stops to greet residents of Chicago. President William Jefferson Clinton delivers a radio address at

the Ritz-Carlton Hotel in Chicago, Illinois. Following the address the President greets guests present. President William Jefferson Clinton greets guests on the tarmac at Chicago O'Hare International Airport in Chicago, Illinois. The President departs en route Minneapolis, Minnesota. The President arrives at Minneapolis International Airport. Departing Air Force One, the President greets a cub scout troop present. The President also greets guests, among them Ann Wynia. President William Jefferson Clinton greets families of slain police officers at the Minneapolis Club in Minneapolis, Minnesota. President William Jefferson Clinton greets guests and police officers at the Minneapolis International Airport prior to departure for Kansas City, Missouri. The President arrives in Kansas City. President William Jefferson Clinton departs Kansas City International Airport en route New York, New York. First Lady Hillary Rodham Clinton and Chelsea Clinton visit the United States Coast Guard Academy in New London, Connecticut. The First Lady greets directors of the academy and reviews the cadet corps. Present includes Secretary of the Navy John Dalton, Margaret Dalton, and Rear Admiral Paul Versaw, among others. The First Lady addresses cadets in the Leamy Hall auditorium. Chelsea Clinton joins onstage. First Lady Hillary Rodham Clinton and Chelsea Clinton visit General Dynamics Electric Boat in Groton, Connecticut. First Lady Hillary Rodham Clinton and Chelsea Clinton attend a performance of "Crazy For You" at the Shubert Theatre in New York, New York. The First Lady and Chelsea Clinton greet cast & crew. Marine One is photographed at the Wall Street Landing Zone in New York, New York. Photographs from September 25, 1994 are as follows: President William Jefferson Clinton confers with senior staff at the Waldorf-Astoria Hotel in New York, New York. Present include Harold Ickes, Tony Lake, Dee Dee Myers, Secretary of State Warren Christopher, Thomas "Mack" McLarty, Andrew Friendly, and Wendy Smith. President William Jefferson Clinton attends a reception for African Heads of State at the Waldorf-Astoria Hotel in New York, New York. President includes Ambassador Madeleine Albright, Secretary of State Warren Christopher, Tony Lake, and Molly Raiser, among others. President Clinton and President Henri Konan Bédié of Côte d'Ivoire (Ivory Coast) address the event. President William Jefferson Clinton and First Lady Hillary Rodham Clinton greet volunteers at the Waldorf-Astoria Hotel in New York, New York. Also photographed include Ambassador Madeleine Albright and Bruce Lindsey, among others. The President also meets with Mayor Rudolph Giuliani and President Alija Izetbegovic of the Republic of Bosnia & Herzegovina in separate meetings. President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Chelsea Clinton attend church service at the Bethel African Methodist Episcopal (A.M.E.) Baptist

Church in Harlem, New York. Also present is Governor Mario Cuomo. The President and Governor Cuomo address the event.

Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
