Summary

The photographs processed in this segment were created on September 27, 1994 through September 29, 1994. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed. Of particular focus is a official state visit of Russian President Boris Yeltsin to the White House and related events around Washington, DC.

Scope and Content Note

FOIA 2016-0984-F (Segment 91) is a request for all Clinton Administration White House photographs taken from January 1, 1994 through December 31, 1994. The photographs processed in this segment were created on September 27, 1994 through September 29, 1994. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed. Of particular focus is a official state visit of Russian President Boris Yeltsin to the White House and related events around Washington, DC. Photographs from September 27, 1994 are as follows: President William Jefferson Clinton and First Lady Hillary Rodham Clinton host a state dinner for President Boris Yeltsin (Борис Николаевич Ельцин) and Anastasia "Naina" Isofovna Yeltsina (Анастасия "Наина" Иосифовна Ельцина) of Russia at the White House. The Clintons and Yeltsins tour the White House Residence. Also photographed are the Clintons and Yeltsins greeting guests. Photographs from September 28, 1994 are as follows: President William Jefferson

Clinton jogs on The Mall in Washington, DC. Following the jog the President greets White House groundskeepers and staff mess personnel. President William Jefferson Clinton meets with President Boris Yeltsin of Russia & business corporate officers in the Cabinet Room of the White House. Present includes Vice President Albert Gore, Jr., Ambassador Thomas Pickering, Secretary of State Warren Christopher, Secretary of the Treasury Lloyd Bentsen, Secretary of Commerce Ron Brown, Mickey Cantor, Tony Lake, Robert Strauss, and Strobe Talbott, among others. President William Jefferson Clinton attends a private luncheon with President Boris Yeltsin of Russia in the Yellow Oval Room of the White House. Also present is Strobe Talbott. President William Jefferson Clinton and President Boris Yeltsin attend a joint reception for United States business representatives at the Corcoran Art Gallery in Washington, DC. Present includes Vice President Albert Gore, Jr. and Robert S. Strauss (Chairman; United States/Russian business council). President William Jefferson Clinton meets with Vice President Albert Gore, Jr., Tony Lake, Strobe Talbot, Dee Dee Myers, Nicholas Burns, Rose Gottemoeller, George Stephanopoulos, and Mark Gearan in the Red Room of the White House. President Clinton and President Boris Yeltsin are announced into the East Room of the White House for a signing ceremony & press conference. Prior to the event the Presidents proceed to the East Room with Molly Raiser and meet with First Lady Hillary Rodham Clinton and Mrs. Anastasia Isofovna Yeltsina in the Blue Room. President William Jefferson Clinton and First Lady Hillary Rodham Clinton arrive at the Russian Embassy in Washington, DC. Present are President Boris Yeltsin, Mrs. Anastasia Isofovna Yeltsina, Vice President Albert Gore, Jr., Toby Gati, Henry Kissinger, Zbigniew W Brzezinski, and Strobe Talbott. President Clinton & President Yeltsin participate in a signing ceremony. President William Jefferson Clinton and First Lady Hillary Rodham Clinton visit the Library of Congress with President Boris Yeltsin and Mrs. Anastasia Isofovna Yeltsina. President Clinton and President Yeltsin cut a ribbon for an exhibit opening. Also present include Dr. James Billington, Senator Ted Stevens, Senator Bill Bradley, and Representative Tom Foley, among others. First Lady Hillary Rodham Clinton meets with Adam Clymer in the Map Room of the White House. First Lady Hillary Rodham Clinton and Mrs. Anastasia Isofovna Yeltsina visit George Washington University in Washington, DC. Van Cliburn is Present. The First Lady and Mrs. Yeltsina visit medical staff and patients at Georgetown University Medical Center and tour the pediatric intensive care unit. The First Lady and Mrs. Yeltsina visit with children and attend a meeting with hospital staff. First Lady Hillary Rodham Clinton and Mrs. Anastasia Isofovna Yeltsina greet visitors at the Kennedy Center in Washington, DC. The First Lady and

Mrs. Yeltsina attend a luncheon at the concert & opera house. Present includes James Wolfenson and dancers, who are greeted following the luncheon. Miscellaneous photographs of President William Jefferson Clinton and First Lady Hillary Rodham Clinton departing the White House. Also photographed is President Clinton petting Socks the cat. Miscellaneous photographs of White House staffers at the White House, including staff of the Scheduling Office in the Oval Office, Brian McPartlin, Catherine Cornelius, and Barbara Kinney. Photographs from September 29, 1994 are as follows: First Lady Hillary Rodham Clinton speaks at "National Primary Care Day" at George Washington University's Ross Hall in Washington, DC. Following the remarks the First Lady greets participants present. First Lady Hillary Rodham Clinton meets with the White House preservation committee in the Blue Room of the White House.

Records that were responsive to this FOIA request were found in one collection area and one series— Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
