Summary

The segment consists of photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Scope and Content Note

FOIA 2016-0984-F (Segment 93) is a request for all Clinton Administration White House photographs taken September 28, 1994; October 2, 1994, through October 4, 1994. Select photo contact sheets from October 4, 1994, were previously processed in case 2021-0645-F. The Finding Aid inventory will reflect the previously processed photo contact sheets. The Clinton Presidential records to be opened consist of photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, official phone calls, photo-ops, etc. involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed. Photographs from September 28, 1994, are as follows: President Clinton meets President Boris Yeltsin of Russia and Business Corporate Officers in the Cabinet Room of the White House. Meeting participants include Vice President Albert Gore, Secretary Lloyd Bentsen, Secretary Warren Christopher, and others. Photographs from October 2, 1994, are as follows: First Lady Hillary Rodham Clinton greets people on the airplane prior to departing Miami, Florida. U.S. Secret Service agents stand outside the Foundry United Methodist Church in Washington, DC. Photographs from October 3, 1994, are as follows: President Clinton addresses members of the Baptist Press in the Old Executive Office Building (EOB) President Clinton meets with Foreign Minister Shimon Peres of Israel and Crown Prince Hassan of Jordan in the Oval Office. President Clinton, Foreign Minister Peres, and Crown

Prince Hassan make press statements in front of the West Wing of the White House. Participants at the press statement include Vice President Albert Gore, Secretary Warren Christopher, Martin Indyk, and others. The principals announce a peace agreement between Jordan and Israel. President Clinton speaks to Phil Lader following the meeting with the Baptist Press in the Old Executive Office Building (OEOB). President Clinton delivers an announcement to business supporters regarding GATT (General Agreement on Tariffs and Trade) in front of the West Wing. Present at the announcement include Senator George Mitchell and Carla Hills, former U.S. Trade Representative. President Clinton holds an economic briefing in the Oval Office with Laura Tyson and others. Photographs from October 3, 1994, Continued: First Lady Hillary Rodham Clinton meets and makes remarks to the new class of White House Fellows in the Truman Room at the White House Conference Center. First Lady Hillary Rodham Clinton meets with Sara Erman in the White House. President Clinton and First Lady Hillary Rodham Clinton address a party for healthcare policy staff in the Indian Treaty Room at the Old Executive Office Building (OEOB). The Clintons pose for a group photo with the staff including Ira Magaziner. President Clinton meets with Foreign Minister Qian Qichen of China in the Oval Office. Meeting participants include Secretary Warren Christopher, Tony Lake, and Bowman Cutter. First Lady Hillary Rodham Clinton attends the Pen/Faulkner Reading at the Folger Shakespeare Library in Washington. President Clinton addresses the Kathleen Brown Fundraiser at the Sheraton Carlton Hotel in Washington. President Clinton and Senator Charles Robb address a Virginia Victory Rally at the Sheraton Premiere Hotel in McLean, Virginia. President Clinton participates in a briefing prior to his meeting with President Nelson Mandela of South Africa. Meeting participants include Vice President Albert Gore, April Glaspie, Tony Lake, and Leon Panetta. Photographs from October 4, 1994, are as follows: President Clinton goes jogging on the National Mall in Washington. Vice President Albert Gore meets Senator Howard Metzenbaum and his grandson at the White House. Senator Metzenbaum and guests visit the Oval Office for photos. President Clinton and First Lady Hillary Rodham Clinton greet President Nelson Mandela and his daughter Zindzi Mandela-Hlongwane at the South Portico driveway. The Clintons attend the State Arrival Ceremony for President Mandela on the South Lawn of the White House. President Clinton and President Mandela review the troops on the South Lawn. The Clintons and the Mandelas greet guests in the residence area of the White House. Photographs from October 4, 1994, Continued: The Clintons show Mandela's the Lincoln bedroom. President Clinton and President Mandela meet in the Yellow Oval Room. President

Clinton and President Mandela talk in the Treaty Room office and Grand Foyer. First Lady Hillary Rodham Clinton and Zindzi MandelaHlongwane meet in the Map Room. The Clinton wave goodbye to the Mandelas from the North Portico steps. President Clinton walks along the White House Colonnade with Leon Panetta. President Clinton meets in the Oval Office with Senator Mark Hatfield, Representative Martin Lancaster, Karen Johnson, Phil Lader, and Linda Lader. President Clinton meets with Black mayors in the Roosevelt Room. President Clinton meets in the Oval Office with Representative Sam Gejdenson.

Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
