Summary

The segment consists of photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Scope and Content Note

FOIA 2016-0984-F (Segment 101) is a request for all Clinton Administration White House photographs taken October 22, 1994, through October 27, 1994. Numerous photo contact sheets from October 24, 1994, through October 27, 1994, were previously processed in cases 2016- 0242-F, 2016-0871-F, and 2021-0642-F. The Finding Aid inventory will reflect the previously processed photo contact sheets. The Clinton Presidential records to be opened consist of photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, official phone calls, photo-ops, etc. involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed. Photographs from October 22, 1994, are as follows: President Clinton greets police and others prior to departing San Francisco, California and traveling to Seattle, Washington. Photographs from October 23, 1994, are as follows: President Clinton addresses a Coordinated Campaign Fundraiser at the Seattle Center. Event participants include Governor Mike Lowry, Larry Brown, Boeing Machinist, Sgt. John Manning, Police Officer, Mikelle Mathers, AmeriCorps participant, and others. President Clinton greets police and others prior to departing Seattle and traveling to Cleveland, Ohio. The President talks to reporters next to Air Force One in Seattle. Harold Ickes takes notes near the press briefing. President Clinton arrives in Cleveland and is met by Cleveland Mayor Mike White at the airport. Photographs

from October 24, 1994, are as follows: President Clinton addresses The City Club luncheon in Cleveland. The President greets supporters including Stephanie Tubbs-Jones at The City Club. The President greets and talks with a disabled child at the luncheon. President Clinton participates in a media interview at The City Club. President Clinton greets people prior to departing Cleveland and travels to Akron, Ohio on Marine One. President Clinton arrives in Akron and is met by Senator John Glenn, Senator Howard Metzenbaum, and others. The President is presented with a key to the city of Akron. President Clinton addresses a rally for Representative Tom Sawyer in Akron, Ohio. Photographs from October 24, 1994, Continued: President Clinton visits the public/private economic development site at Inventure Place in Akron. President Clinton wears a white hard hat and tours the site with Representative Tom Sawyer, Mayor Don Plusquellic, Joel Hyatt and others. President Clinton greets people on the street. President Clinton greets people at the airport prior to departing Akron and traveling to Andrews Air Force Base in Maryland. President Clinton talks with Harold Ickes and other staff aboard Air Force One during the flight. President Clinton arrives at Andrews Air Force Base and walks on the tarmac with Alexis Herman and Harold Ickes. President Clinton greets delegates to the peace signing between Jordan and Israel that were present at Andrews Air Force Base. First Lady Hillary Clinton addresses a reception for Representative Bob Carr at the Novi Hilton in Michigan. The First Lady greets Maryanne Hanson, Jay Alix, and others. First Lady Hillary Rodham Clinton departs Detroit and travels to Andrews Air Force Base. President Clinton greets First Lady Hillary Rodham Clinton on the tarmac following her trip to Michigan. First Lady Hillary Rodham Clinton greets Jim Maloney and family at the home of Dick Morris and Ellen McGann in West Redding, Connecticut, host of the Maloney fundraiser. First Lady Hillary Rodham Clinton greets police and others prior to departing White Plains, New York and traveling to Detroit, Michigan. Photographs from October 25, 1994, are as follows: President Clinton signs various bills at his desk in the Oval Office. Vice President Albert Gore, John Podesta, and Leon Panetta are present in the Oval Office. Photographs from October 26, 1994, are as follows: First Lady Hillary Rodham Clinton and First Lady Suzanne Mubarak of Egypt depart Qubba Palace. First Lady Hillary Rodham Clinton and First Lady Suzanne Mubarak visit the Pyramids, the Pyramid Guest House, and the Boat House in Cairo, Egypt. The First Ladies and their staff have lunch at a local restaurant in Cairo. Photographs from October 26, 1994, Continued: Views of the Cairo skyline. President Clinton, First Lady Hillary Rodham Clinton, and Secretary Warren Christopher say goodbye to President Hosni Mubarak and First Lady Suzanne

Mubarak prior to departing Cairo International Airport. The Clintons wave from the top step of Air Force One. President Clinton standing with King Hussein at Parliament in Amman, Jordan. First Lady Hillary Rodham Clinton stands with Queen Noor at Parliament.

While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
