## **Summary**

Photographed includes staff in Egypt on October 26, 1994, unidentified individuals in Damascus, Syria on October 27, 1994, Crown Prince Saad Abdullah Al-Sabah ( حابصلالملكالاسلامىالكويتى ) in Kuwait on October 28, 1994, and President William Jefferson Clinton returning to the White House following his trip to the Middle East, including shots of Air Force One & Marine One.

## **Scope and Content Note**

FOIA 2016-0984-F (Segment 103) is a request for all Clinton Administration White House photographs taken from January 1, 1994 through December 31, 1994. The photographs processed in this segment were created on October 25, 1994 through October 29, 1994. Photographed includes staff in Egypt on October 26, 1994, unidentified individuals in Damascus, Syria on October 27, 1994, Crown Prince Saad Abdullah Al-Sabah ( حابصلالملكالاسلامىالكويتى ) in Kuwait on October 28, 1994, and President William Jefferson Clinton returning to the White House following his trip to the Middle East, including shots of Air Force One & Marine One. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
