Summary

This collection contains systematically processed materials from White House Office of Records Management (WHORM) Subject Code CO115. This is the code that WHORM assigned to documents relating to the Principality of Monaco. The collection consists of two letters from President Clinton to Prince Rainier III. The first congratulates him on the 700th anniversary of the reign of the Grimaldi dynasty in 1997. The second offers congratulations on the 50th anniversary of the Prince's reign in 1999.

Scope and Content Note

This collection consists of material found in WHORM Subject File CO115. This is the code that the White House Office of Records Management assigned to documents relating to the Principality of Monaco. The United States and Monaco have maintained healthy diplomatic relations since the two nations exchanged consular officials in the 1860s. During the Clinton Administration, Prince Rainier III of the House of Grimaldi was Head of State in Monaco. From 1956 until her death in 1982, Prince Ranier was married to American actress Grace Kelly. The collection contains two letters from President Clinton to Prince Rainier. The first congratulates him on the 700th anniversary of the reign of the Grimaldi dynasty in 1997. The second offers congratulations on the 50th anniversary of the Prince's reign in 1999.
