## **Summary**

This collection consists of records from the files of White House Counsel's Office, regarding the consideration and appointment of nominees to the U.S. Courts of Appeals. This collection consists of correspondence, memoranda, newspaper clippings, articles from legal journals and LexisNexis, reports, press releases, resumes, and letters from individuals, organizations, and Congressional leaders recommending the nominees.

## **Scope and Content Note**

The materials in FOIA 2006-1067-F (Segment 3) are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the following FOIA's for related material: 2006-1067-F (Segments 1 & 2) 2006-0188-F 2010-0650-F 2012-0203-F 2013-0670-F 2019-0481-F. This collection contains records of the White House Counsel's Office from 1993 thru 1999, regarding the search, background, and selection of appointees to the U.S. Court of Appeals. The Court of Appeals is divided into 11 circuits by geographic region with 1 court for the District of Columbia and 1 court for the Federal Circuit. The Court of Appeals is second only in judicial importance and prominence to the U.S. Supreme Court. President Clinton appointed 66 judges to the U.S. Court of Appeals, beginning in August 1993 thru June 2000. However, this FOIA segment contains only a small selection of the 66 judges appointed by President Clinton. Future FOIA segments will contain records on additional nominees. Finally, the researcher should be aware that several folders are closed almost in whole due to personal privacy restrictions. FOIA request 2006-1067-F (Segment 3) consists of correspondence, memoranda, newspaper and magazine articles, scholarly articles from legal journals, reports, speeches, press releases, and resumes. The records also contain LexisNexis articles documenting the legal

opinions of the various appeals court nominees and letters from individuals, organizations, and members of Congress recommending the nominees.

Records that are responsive to this FOIA request were found in these collection areas: White House Staff and Office Files, Counsel's Office. This segment is arranged by staff member and then alphabetically by surname.

### **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
