Summary

This collection consists of electronic records that related to Carol Browner and the North American Free Trade Agreement (NAFTA), between the dates of January 20, 1993 and December 8, 1993-the date the trade agreement was signed into law by President Clinton. This collection contains primarily of press & press clippings, news reports, and some internal correspondence between White House staffers.

Scope and Content Note

The materials in FOIA 2023-0716-F (Segment 1) are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. The researcher submitted a request for records that related to Carol Browner and the North American Free Trade Agreement (NAFTA), between the dates of January 20, 1993 and December 8, 1993-the date the trade agreement was signed into law by President Clinton. Ms. Browner served as the Administrator of the Environmental Protection Agency (EPA) for all eight years of President Clinton's administration. Electronic records responsive to this request consist primarily of press & press clippings, news reports, and some internal correspondence between White House staffers. System of Arrangement

Records that are responsive to this FOIA request were found in these collection areas— Clinton Presidential Records: (SAS) Automated Records Management System [Email]. The Executive Office of the President (EOP) subsystem of the Electronic Records Archive (ERA) contains electronic records created or received by Clinton Administration officials. These records are stored in Search and Access Sets (SAS) that represent their originating computer program. Search strings are used to locate records responsive to FOIA requests, and responsive assets are placed into Search Results Lists (SRLs). Depending on the complexity of the search, there may be multiple SRLs within each SAS. The Automated Records Management System (ARMS) is a database that contains email records of the Executive Office of the President. This system maintained unclassified Presidential email.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (17 U.S.C. Chapter 1) which governs the making of photocopies or other reproductions of copyrighted material.
