Summary

This collection contains textual records relating to W. Bowman Cutter and the North American Free Trade Agreement (NAFTA) from January 20, 1993 to December 8, 1993. These documents are cables, emails, and memoranda dated between January 8, 1993 and December 8, 1993. This is the third segment and release of records related to Freedom of Information Act (FOIA) request 2023-0710-F. Open records in this segment include several emails related to information distribution, trade issues with Japan, and notes from an NEC Deputies Meeting. There are also important memos related to NAFTA negotiations with Canada and the court case *Public Citizen v. Office of the United States Trade Representative* (5 F.3d 549 (D.C. Cir. 1993)).

Scope and Content Note

The materials in FOIA 2023-0710-F (Segment 3) are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. This collection contains records from the National Security Council related to W. Bowman Cutter and the North American Free Trade Agreement (NAFTA). These documents are cables, emails, and memoranda dated between January 8, 1993 and December 8, 1993. This is the third segment and release of records related to Freedom of Information Act (FOIA) request 2023-0710-F. The National Economic Council (NEC) was part of the Office of Policy Development and considered an equal in organization to the National Security Council. While the role of the National Economic Council was not primarily foreign or international, some issues were inevitably so. Open records in this segment include several emails related to information distribution, trade issues with Japan, and notes from an NEC Deputies Meeting. There are also important memos related to NAFTA negotiations with Canada and the court case *Public Citizen v. Office of the United States Trade*

Representative (5 F.3d 549 (D.C. Cir. 1993)). W. Bowman Cutter, more frequently referred to as Bo, was already familiar with government work when he joined the Clinton Administration in 1993. Previously he served in the Office of Management and Budget during the Carter administration. Cutter was Deputy Assistant to the President for Economic Policy in the National Economic Council.
