## **Summary**

This collection consists of records sent to or by Robert Reich concerning the North American Free Trade Agreement (NAFTA), between January 20 and December 8, 1993. The electronic records responsive to this request came from the Automated Records Management System (ARMS). Records to be opened include press, press clippings, reports, and internal correspondence between White House staffers.

## **Scope and Content Note**

The materials in FOIA 2023-0715-F (Segment 1) are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. The researcher submitted a request for electronic records that related to Robert Reich and the North American Free Trade Agreement (NAFTA), between the dates of January 20, 1993 and December 8, 1993- the date the trade agreement was signed into law by President Clinton. Robert Reich was confirmed as President Clinton's first Secretary of Labor on January 21, 1993, and served in that role until 1997. He was one of the leading proponents and spokesmen for NAFTA in the Clinton administration. Electronic records responsive to this request consist of press & press clippings, reports, and internal correspondence between White House staffers.

## **System of Arrangement**

Records that are responsive to this FOIA request were found in these collection areas— Clinton Presidential Records: (SAS) Automated Records Management System [Email]. The Executive Office of the President (EOP) subsystem of the Electronic Records Archive (ERA) contains electronic records created or received by Clinton Administration officials. These records are stored in Search and Access Sets (SAS) that represent their originating computer program. Search strings are used to locate records responsive to FOIA requests, and responsive assets are placed into Search Results Lists (SRLs). Depending on the complexity of the search, there may be multiple SRLs within each SAS. The Automated Records Management System (ARMS) is a database that contains email records of the Executive Office of the President. This system maintained unclassified Presidential email.

### **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

### **Copyright**

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (17 U.S.C. Chapter 1) which governs the making of photocopies or other reproductions of copyrighted material.

### **Provenance**

Official records of William Jefferson Clinton's presidency are housed at the Clinton Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).
