Summary

This collection consists of records related to the White House Office of Science and Technology Policy (OSTP) and any mention of advanced aerospace vehicles, faster than light travel, or time travel.

Scope and Content Note

The materials in FOIA 2024-0700-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. A collection of interest is 2008-1524-F: Records of the Office of Science and Technology Policy, 1993-2001. Materials responsive to this FOIA request include emails mentioning the White House Office of Science and Technology Policy (OSTP) and advanced aerospace vehicles, faster than light travel, or time travel.

System of Arrangement

Records that are responsive to this FOIA request were found in these collection areas— Clinton Presidential Records: (SAS) Automated Records Management System [Email]. The Executive Office of the President (EOP) subsystem of the Electronic Records Archive (ERA) contains electronic records created or received by Clinton Administration officials. These records are stored in Search and Access Sets (SAS) that represent their originating computer program. Search strings are used to locate

electronic records responsive to FOIA requests, and responsive assets are placed into Search Results Lists (SRLs). Depending on the complexity of the search, there may be multiple SRLs within each SAS. The Automated Records Management System (ARMS) is a database that contains email records of the Executive Office of the President. This system maintained unclassified Presidential email.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (17 U.S.C. Chapter 1) which governs the making of photocopies or other reproductions of copyrighted material.
