Summary

The photographs processed in this segment were created from December 8, 1994, through December 10, 1994. Numerous photo contact sheets in this segment from December 8, 1994, and December 10, 1994, were previously processed in case 2018-0084-F. The Finding Aid inventory will reflect the previously processed photo contact sheets. The segment consists of photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Scope and Content Note

FOIA 2016-0984-F (Segment 117) is a request for all Clinton Administration White House photographs taken from January 1, 1994, through December 31, 1994. The photographs processed in this segment were created on December 8, 1994, through December 10, 1994. Numerous photo contact sheets in this segment from December 8, 1994, and December 10, 1994, were previously processed in case 2018-0084-F. The Finding Aid inventory will reflect the previously processed photo contact sheets. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed. Photographs from December 8, 1994, are as follows: President Clinton, First Lady Hillary Rodham Clinton, Vice President Albert Gore, and Tipper Gore arrive in Miami, Florida and attend a rally at the Sheraton Bal Harbour Hotel. Photographs from December 9, 1994, are as follows: President Clinton goes jogging near the Ocean in Miami. The

President greets people at the Sheraton Bal Harbour Hotel and others after his run. Callie Shell, Vice President Gore's photographer, talks on the telephone on the balcony with Dee Dee Myers, Sharon Farmer, and others at the Sheraton Bal Harbour Hotel. President Clinton works on his Summit of Americas speech with Vice President Albert Gore, Mickey Kantor, Sandy Berger, Erskine Bowles, Tony Lake, and Bob Boorstin at the Sheraton Bal Harbour Hotel. President Clinton and Vice President Albert Gore deliver remarks for the Summit of Americas Gala at the Jackie Gleason Theater for the Performing Arts in Miami. They are joined by First Lady Hillary Rodham Clinton and Tipper Gore at a reception for gala sponsors. The Clintons talk with staff and others in a holding room area at the Gleason Theater. Staff include Bruce Lindsey, Susan Thomases, Dee Dee Myers, Kelly Craighead, Erskine Bowles, and others. President Clinton and Vice President Albert Gore meet with Congressional delegates to the Summit of the Americas and they field questions from the delegates at the Fontainebleau Hotel in Miami. First Lady Hillary Rodham Clinton visits Jackson Memorial Hospital in Miami. The First Lady greets hospital personnel, patients, and children. A child listens to the First Lady's heart with a stethoscope. The First Lady talks to staff and looks at a baby in an incubator. First Lady Hillary Rodham Clinton greets hotel personnel at the Sheraton Bal Harbour Hotel. First Lady Hillary Rodham Clinton visits Drew Elementary School in Miami. The First Lady greets students in their classrooms and interacts with students.

Photographs from December 9, 1994, Continued: President Clinton and First Lady Hillary Rodham Clinton arrive at the Biltmore Hotel Landing Zone in Coral Gables, Florida. President Clinton and Hillary Rodham Clinton arrive at the Biltmore Hotel and greet the Summit of the Americas host committee, Florida Delegation, and others. President Clinton and First Lady Hillary Rodham Clinton greet guests at a reception for U.S. private sector and Non-Governmental Organization (NGO) business leaders at the Biltmore Hotel. President Clinton greets Biltmore Hotel personnel. Photographs from December 10, 1994, are as follows: President Clinton and Vice President Albert Gore greet Summit of the Americas Heads of State and others in Miami at the Vizcaya Museum and Gardens. The President and Vice President Gore participate in the first working session of the Summit of the Americas in the courtyard. Views of the "Eaton Eagle" in Miami. President Clinton and Hillary Rodham Clinton attend a sponsor's reception for Summit of the Americas Gala leaders and spouses at the Hyatt Regency Hotel in Miami. The Clintons also attend a reception at the Miami Convention Center prior to the gala. Views of gala performers and entertainers. President Clinton greets Liza Minnelli at the gala. President Clinton,

First Lady Hillary Rodham Clinton, and Summit of the Americas leaders and spouses proceed from the River Walk in Miami to board the “Virginian” yacht to Fisher Island. The Clintons and Summit leaders attend a dinner at the Vanderbilt Mansion. Views of the Clintons alone at the dinner.

Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
