Summary

The photographs processed in this segment were created on December 9, 1994 through December 11, 1994. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Scope and Content Note

FOIA 2016-0984-F (Segment 118) is a request for all Clinton Administration White House photographs taken from January 1, 1994 through December 31, 1994. The photographs processed in this segment were created on December 9, 1994 through December 11, 1994. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed. Images responsive to this FOIA segment were previously processed in FOIA case number 2018-0084-F including all material from December 9, 1994, and should be referenced for material processed therein. Photographs from December 10, 1994 are as follows: President William Jefferson Clinton jogs on the beach in Miami, Florida. President William Jefferson Clinton & Vice President Albert Gore, Jr., greet Summit of the Americas heads of state and guests at Vizcaya. The President converses with Prime Minister Jean Chretien of Canada. President Clinton participates in the first working session of the Summit of the Americas. Upon the session's conclusion, the President participates in a concàusa ("joint clause") signing ceremony at Vizcaya in Miami, Florida. Also present includes President Ramiro de León Carpio of Guatemala,

President Ernesto Pérez Balladares González-Revilla of Panama, President José María Figueres Olsen of Costa Rica, President Viole Barrios Torres de Chamorro of Nicaragua, President Carlos Roberto Reina Idiaquez of Honduras, and Prime Minister Manuel Esquivel of Belize, whom all sign the document along with President Clinton. Also photographed are miscellaneous shots of Vizcaya and Brady Williamson in a courtyard. First Lady Hillary Rodham Clinton greets the Summit of the Americas spouses at the Biltmore Hotel in Miami, Florida, where they all attend the Symposium on Children of the Americas and work in break out groups. President William Jefferson Clinton & First Lady Hillary Rodham Clinton attend an event at the Miami Convention Center in Miami, Florida prior to a sponsors' receptions for world leaders & their spouses at the Hyatt Regency Hotel. Photographed at the Gala includes Liza Minnelli, Quincy Jones, and Mort Engelberg, among others. President William Jefferson Clinton & First Lady Hillary Rodham Clinton attend an event on The Virginian yacht prior to proceeding to Fisher Island in Miami, Florida. The President, First Lady, and Summit of the Americas guests depart Terminal Island and proceed to the Vanderbilt mansion for dinner. Also photographed is Dr. Connie Mariano. Prior to the event the First Lady and her staff are photographed at the Occidental Hotel wearing formal wear, including Kelly Craighead, Melanne Verveer, Lisa Caputo, and Patti Solis. Miscellaneous photographs include staff resting in Miami, Florida including Maggie Williams, Kelly Craighead, Lisa Cauto, Capricia Marshall, and Patti Solis. Photographs from December 11, 1994 are as follows: President William Jefferson Clinton greets guests as he departs the Sheraton Bal Harbour in Miami, Florida. President William Jefferson Clinton & First Lady Hillary Rodham Clinton say goodbye to Vice President Albert Gore, Jr. and Mary Elizabeth "Tipper" Gore at Miami International Airport in Miami, Florida. Also photographed is Thomas "Mack" McLarty and guests on the tarmac. The President & First Lady depart Miami en route Andrews Air Force Base. The President speaks with Erskine Bowles, Margaret Jane "Dee Dee" Myers, and Melanne Verveer aboard Air Force One. The President & First Lady depart Air Force One on arrival to Andrews Air Force Base, proceed to the White House via Marine One, and are photographed walking along the South Lawn of the White House. President William Jefferson Clinton & First Lady Hillary Rodham Clinton pose for a group photograph with White House social aids in the East Room of the White House. Present includes Bobby Chunn and Keith Williams. President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Chelsea Clinton attend the annual Christmas in Washington performance at the National Building Museum in Washington, DC. Photographed includes Helen Hunt (master of

ceremonies), George Stevens, Jr., and performers at the event.

Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
