Summary

The photographs processed in this segment were created from February 7, 1995, through February 9, 1995.

Scope and Content Note

FOIA 2016-0985-F (Segment 12) is a request for all Clinton Administration White House photographs taken from January 1, 1995, through December 31, 1995. The photographs processed in this segment were created on February 7, 1995, through February 9, 1995. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed. Photographs from February 7, 1995, are as follows: President Clinton and Vice President Albert Gore meet in the Roosevelt Room with Major League Baseball (MLB) players and MLB team owners to resolve the Baseball Strike. Meeting participants include Federal Arbitrator Bill Utery, Secretary Robert Reich, Bruce Lindsey, Milwaukee Brewers owner Bud Selig, George Stephanopoulos, Pat Griffin, Mike McCurry, and Leon Panetta. President Clinton talks with baseball players in the hallway outside the Roosevelt Room. President Clinton meets with Bud Selig regarding the MLB strike in the West Wing. The meeting was held in Leon Panetta's office. Meeting participants include Secretary Robert Reich, Leon Panetta, Bruce Lindsey, and George Stephanopoulos. President Clinton talks alone with Leon Panetta following the meeting. President Clinton greets and talks alone with First Lady Hillary Rodham Clinton near the elevator on the State Floor. The President addresses a reception for new members of Congress in the East Room. The President and the First Lady greet

the new members and others on the State Floor. President Clinton greets Secretary Richard Riley in the hallway of the Ground Floor Residence. Alexis Herman talks on a telephone in the West Wing and hands the telephone to President Clinton. President Clinton participates in a briefing on Immigration in the Oval Office. Meeting participants include Attorney General Janet Reno, Secretary Robert Reich, Vice President Albert Gore, and members of the U.S. Border Patrol. President Clinton meets with Bill Usery, Vice President Albert Gore, Secretary Robert Reich, Leon Panetta, Bruce Lindsey, George Stephanopoulos, and Mike McCurry in the Oval Office Dining Room. President Clinton delivers an announcement in the Press Briefing Room regarding no resolution to the MLB strike after meetings with players and owners. President Clinton participates in an interview with WMUR (New Hampshire) in Room 459, Old Executive Office Building (OEOB). Prior to the meeting, President Clinton meets in the Oval Office with Mark Gearan, George Stephanopoulos, Lorrie McHugh, Wendy Smith, and others. President Clinton meets in the Cabinet Room with supporters. Vice President Albert Gore, Leon Panetta, Alexis Herman, and others are present at the meeting. Photographs from February 8, 1995, are as follows: President Clinton meets in the Oval Office with Lee Brown, Director of the Office of National Drug Control Policy. Lee Brown presents the President with the 1995 Drug Control Policy Strategy. Following the meeting, Rahm Emanuel briefs the President and Lee Brown on the upcoming Crime Policy event. Vice President Albert Gore and Attorney General Janet Reno are present at the briefing. First Lady Hillary Rodham Clinton greets guests from the Kiwanis Club luncheon in the Blue Room. The First Lady addresses the Kiwanis Club luncheon in the State Dining Room. Additional speakers at the luncheon include John Cuny, Executive Vice President of Anthem Health, and Ian Perdriau, President of Kiwanis International. The First Lady talks alone with Chief Usher Gary Walters in the Cross Hall. Views of the table settings at the luncheon. First Lady Hillary Rodham Clinton greets Sidney Stein and family in the Diplomatic Reception Room. President Clinton addresses the Crime event in Room 459, Old Executive Office Building (OEOB). Participants include Drug Policy Director Lee Brown, Attorney General Janet Reno, Vice President Albert Gore, Police Chief Mary Ann Viverette, Sheriff Gene Kelly, and other law enforcement officers. President Clinton and Vice President Albert Gore greet an unidentified man in the Ground Floor Lobby. President Clinton and Vice President Gore wave at Christopher McNeely (Photographer Bob McNeely's son) in the Photo Office. President Clinton confers with Vice President Albert Gore, Pat Griffin, and Leon Panetta in the Diplomatic Reception Room prior to attending the

Congressional Luncheon in the Map Room. First Lady Hillary Rodham Clinton addresses the National Federation of Black Women Business Owners Awards Luncheon at the Hyatt Regency Hotel in Washington, D.C. Participants include Shirley Caesar, Nicole Clay, Mary Walker, and Alexis Herman. The First Lady greets a group of local children at the hotel. President Clinton greets Michael Carns, George Tenet, and Secretary Warren Christopher in the Oval Office. President Clinton announces Michael Carns as his nominee for Director of the Central Intelligence Agency (CIA) to replace James Woolsey in the Roosevelt Room. Guests include Les Aspin, General Colin Powell, James Woolsey, Senator Arlen Specter, Senator Patrick Leahy, and others. Photographs from February 9, 1995, are as follows: President Clinton meets in the Roosevelt Room with Republican members of Congress including Representative Steve Gunderson. Leon Panetta, George Stephanopoulos, Pat Griffin, and Susan Brophy are present at the meeting. President Clinton meets in the Oval Office with Secretary Warren Christopher, Leon Fuerth, Leon Panetta, Sandy Berger, and others prior to the State Arrival ceremony for Chancellor Helmut Kohl of Germany. President Clinton talks alone with First Lady Hillary Rodham Clinton and Tipper Gore in the Diplomatic Reception Room. President Clinton talks with Secretary Warren Christopher, Molly Raiser, and others prior to the State Arrival ceremony for Chancellor Kohl. The First Lady adjusts the President's scarf in the foyer prior to walking out of the White House to the South Lawn for the State Arrival ceremony. The Clintons greet German Chancellor Helmut Kohl after he arrives at the South Portico. Chancellor Kohl greets Vice President Albert Gore and Tipper Gore. President Clinton and Chancellor Kohl review the troops and address the arrival ceremony. Chancellor Kohl signs the guest book in the Red Room following the arrival ceremony. President Clinton and Chancellor Kohl greet guests including Vice President Gore, Tipper Gore, Secretary Warren Christopher, Mayor Marion Barry of Washington D.C., and others in the Cross Hall. President Clinton participates in a meeting with Chancellor Helmut Kohl of Germany. The White House Press Pool covers the meeting. President Clinton and Chancellor Kohl participate in an expanded meeting in the Cabinet Room with Vice President Albert Gore, Secretary Robert Rubin, Leon Panetta, Tony Lake, Leon Fuerth, and others. President Clinton confers with Vice President Albert Gore, Mike McCurry, Tony Lake, Leon Panetta, George Stephanopoulos, and Mark Gearan in the Oval Office. President Clinton and Chancellor Kohl of Germany walk from the West Wing to the Old Executive Office Building (OEOB). President Clinton and Chancellor Kohl participate in a joint press conference in Room 450 of Old Executive Office Building (OEOB). Socks the cat plays

in the snow-covered White House grounds.

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and 5 the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
