**Summary**

This collection consists of correspondence and memoranda concerning the pardon of Cheryl Ada Elizabeth Little on October 20, 2000.

**Scope and Content Note**

The materials in FOIA 2006-0371-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA request 2006-0371-F contains materials from the Counsel's Office concerning the October 20, 2000 presidential pardon of Cheryl Little. The White House Staff and Office Files of Meredith Cabe contain correspondence between the Counsel's Office and President Clinton. The files include an October 5, 2000 memorandum to the President recommending the pardon of Cheryl Little. Also included are copies of the President's Executive Grant of Clemency.

Records that were responsive to this FOIA request were found in one collection area—Clinton Presidential Records: White House Staff and Office Files. As policy Staff and Office Files are processed at the folder level. That is, individual documents are not selected and removed from a folder for processing.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 22) and the Freedom of Information Act (FOIA) (5 USC 552 as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain.
