Summary

This collection consists of a memorandum from Secretary of Defense Aspin to President Clinton regarding the selection of a new Chairman of the Joint Chiefs of Staff dated from the summer of 1993. This memorandum discusses the biographies of General John Shalikashvili, who was appointed Chairman of the Joint Chiefs of Staff by President Clinton, effective October 25, 1993, and General Joseph Hoar, a publicly acknowledged finalist for the post in August of 1993.

Scope and Content Note

The materials in FOIA 2009-1055-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA.
