Summary

This collection consists of records describing the efforts of the Clinton Administration to pass the Health Security Act, which would have reformed the health care system of the United States. This collection contains memoranda, correspondence, handwritten notes, reports, charts, graphs, bills, drafts, booklets, pamphlets, lists, press releases, schedules, newspaper articles, and faxes. The collection contains lists of experts from the field of medicine willing to testify to the viability of the Health Security Act. Much of the remaining material duplicates records from the previous segments.

Scope and Content Note

The materials in FOIA 2006-0885-F are a selective body of documents responsive to the topic of the FOIA. Additional material for this FOIA case has been processed in segments 1-3. FOIA 2006-0885-F contains records regarding President Clinton's attempts to put into effect a total recasting of the health care system in the United States. First Lady Hillary Rodham Clinton was appointed as the head of the Health Care Task Force (HCTF). She expended a tremendous amount of energy trying to get health care reform through Congress. She traveled across the country holding numerous hearings, conferred with Senators and Representatives on countless occasions, and went outside the government time and time again as she valiantly attempted to broker a deal. However, despite her best efforts Clinton's plan, known as the Health Security Act, didn't even get introduced into Congress in 1994. The records in this portion of the FOIA case contain memoranda, correspondence, handwritten notes, reports, charts, graphs, bills, drafts, booklets, pamphlets, lists, press releases, schedules, newspaper articles, and faxes. There is a large amount of information related to prospective speakers and likeminded experts who ostensibly

might testify to the viability of Clinton's health care plan. A leading mental health advocate, Dr. Bernie Arons played a key role in the drive toward health care reform in the Clinton Administration. He served as mental health and substance abuse advisor to Tipper Gore and teamed up with her to co-chair the Mental Health and Substance Abuse Working Group for the President's Task Force on National Health Reform. Moreover, Arons held high governmental positions that permitted him to shape mental health policy on a national level. These posts included Director of the Center for Mental Health Services at SAMHSA (Substance Abuse and Mental Health Services Administration) and Senior Science Advisor to the Director of the National Institute of Health. In 2009 he was appointed the Director of Medical Affairs at Saint Elizabeth's Hospital in Washington, D.C. This enabled Arons to be the supervisor of all clinical programs at the Hospital, including the psychiatry residency training program. The Staff and Office Files of Bernie Arons are composed primarily of drafts, bills, and briefing papers. For instance, there is a voluminous copy of the Health Security Act which contains all parts of the bill and could perhaps serve as a starting point for somebody interested in Clinton's health care reform plan. Apparently teamed up with Larry Levitt on health care matters, Gary Claxton worked in the White House in the first part of the Clinton Administration. The two men spent most of their time dealing with cost containment, insurance reform, financing issues, and the various components of the Health Security Act. In short, they were actively engaged in the ongoing struggle for a complete restructuring of the health care system in the United States. From March 1997 through January 2001, Claxton held the position of Deputy Assistant Secretary for Health Policy in the Department of Health and Human Services. He advised the Secretary on any number of health policy issues ranging from the financing of prescription drugs to the expansion of patient rights. Claxton's current posts are that of a Vice President, the Director of the Health Care Marketplace Project and Co-Director of the Program for the Study of Health Reform and Private Insurance at the Henry J. Kaiser Family Foundation. He oversees cutting edge proposals designed to stay ahead of the curve in the health care market and to capitalize on provisions of the Affordable Care Act. The Staff and Office Files of Gary Claxton consist of memoranda, handwritten notes, reports, publications, bills, and drafts focusing on legislation aimed at totally overhauling the health care system then in use across the nation. In addition, charts, graphs, and detailed statistical analyses crop up throughout his records as plans of varying degrees of reform and change are subjected to exhaustive study and discussion. Nothing is too minute or out of the ordinary to escape detailed inspection. For

example, there is a paper entitled "Very Theoretical Insurance Reform Options" that breaks down the issue to a standardized benefit package, small group reforms, and purchasing groups. Larry Levitt served as Senior Health Policy Advisor to the Clinton White House and Department of Health and Human Services. In this capacity he helped the President in the formulation of the Health Security Act and other related activities. Like Gary Claxton, Levitt is presently employed at the Kaiser Family Foundation where he holds the positions of Vice President for Special Initiatives, Senior Advisor to the President, and Co-Executive Director of the Program for the Study of Health Reform and Private Insurance. The Staff and Office Files of Larry Levitt consist of a wide variety of materials. These records compare the Clinton Administration's proposal to related health insurance plans and similar legislative efforts. Levitt's files also describe comparative, financial, and legislative analysis and models of assorted health plans. Several 3 1/2" diskettes were located in the Staff and Office Files of Larry Levitt. These diskettes' files contain briefing papers and tables. The records from these diskettes have been processed electronically and are available for research in that format. Gary Cohen has several boxes of material associated with the Health Care Task Force. It is unclear what his exact duties were but he seems to have been actively engaged from the White House in arranging for speakers to appear at various functions and meetings in an effort to put the best face on the Administration's reform of the health care system in the United States. In recent years, he has held several leadership positions in the field of global medical technology and become a passionate advocate in the fight to improve the state of health around the world. In addition, Cohen serves as an advisor to the Clinton Global Initiative (CGI). The Staff and Office Files of Gary Cohen contain correspondence, memoranda, faxes, lists, press releases, schedules, newspaper articles, and business cards focusing on the lining up of experts who could advance the cause of Clinton's health care plan. Events are grouped together by month and sometimes have handwritten notes directing a specific person to go after a specific individual to fulfill a speaking engagement. Additionally, the Department of Health and Human Services (HHS) schedules include lists of potential speakers and even note possible happenings that the administration declined to accept. In some instances, health care activities ended up being organized by state. During the first term of the Clinton Administration Christine Heenan worked on the Domestic Policy Council, and in that capacity served as Senior Health Policy Analyst. She advised the President on health care issues, wrote speeches for him, Mrs. Clinton, and Vice President Al Gore. Subsequent to leaving politics, Heenan was the Director of

Community and Government Relations at Brown University (1995-2000), founded and then became CEO of Clarendon Group Inc. (2000-2008), a communications and government relations consulting firm, and concurrently held the position of senior advisor at Public Strategies (2005-2008), a national public affairs firm with offices at several different locations in the United States. At the present time she holds the post of Vice President for Public Affairs and Communications at Harvard University. Her duties include overseeing communications and government community relations and acting as senior advisor to the president, provost, and governing boards. The Staff and Office Files of Christine Heenan consist primarily of booklets, pamphlets, and assorted other publications that deal with health care legislation introduced by members of Congress. These bills are compared unfavorably to Clinton's proposal on almost every level. Handwritten notes of various meetings involving key players such as Ira Magaziner and Hillary Clinton can be found throughout the collection. It should be noted that the electronic records in this segment of Christine Heenan's Files were actually processed in segment 2 of 2006-0885-F and can be found there. One of the major movers and shakers in the push for health care reform during the Clinton Administration, Chris Jennings joined the White House in 1994 and assumed the position of Special Assistant to the President for Health Policy. In that capacity he played a key role in health insurance reform, quality assurance, the formation of the President's Advisory Commission on Quality and Consumer Protection, and helping Hillary Clinton convey to Congress the main components of the proposed complete revamping of the health care system. Jennings served as perhaps her closest advisor and confidante. After the defeat of Clinton's plan, he remained in the administration and in January 1997 became Deputy Assistant to the President for Health Policy Development in the White House Domestic Policy Council. Perhaps his most important accomplishments here concerned the passage of the State Children's Health Insurance Program and the push for a real and substantive Patients' Bill of Rights. In the years since leaving the White House, Jennings headed up his own health care and lobbying firm that numbered labor unions, the AARP (American Association of Retired Persons), and nonprofit groups such as the Clinton Global Initiative (CGI) among its clients. During 2013, Jennings was hired by the Obama Administration to aid in the final implementation of President Obama's Patient Protection and Affordable Care Act. The Staff and Office Files of Chris Jennings consist principally of material dealing with the various bills devoted to reforming the health care system. These records take the form of publications such as booklets, pamphlets, reports, and other similar types of things. One booklet is

entitled "Congressional Health Care Workshops, September 1993;" a report is entitled "Achievements of the U.S. Senate Special Committee on Aging." Bills covered include those of Senate Majority Leader George Mitchell, Senators Robert Dole and Robert Packwood, and the administration-sponsored Health Security Act of 1993, the handiwork of Bill and Hillary Clinton and to a lesser extent Senator Edward Kennedy. The analysis of each respective piece of legislation comes with all manner of charts and graphs and detailed breakdowns outlining possible options and so forth. Probably of considerable value to researchers, there are lists of meetings Hillary Clinton had with members of Congress to try and sell health care reform and prominent individuals in business and other areas who might be supportive of Clinton's initiative to bring universal coverage to all Americans. Closely associated with Bill and Hillary Clinton over the years, Jennifer Klein served on the Domestic Policy Council as a Special Assistant to the President from 1993-1999. She helped him in a significant way in his push for health care reform. After leaving the administration, Klein eventually worked for the former First Lady as a Deputy in the Office of Global Women's Issues at the Department of State. Staying at this post for nearly four years (May 2009-March 2013), she currently acts as a Consultant at the Office of Hillary Clinton in Washington, D.C. Carolyn Gatz acted as manager of the writing process that produced President Clinton's health care plan. She worked in the office of Ira Magaziner and provided much in the way of pithy quotes in the newspapers and magazines of the period. Her current position is that of Trustee on the Board of Norton Healthcare, Inc. in Louisville, Kentucky. The Staff and Office Files of Jennifer Klein and Jennifer Klein/Carolyn Gatz consist principally of handwritten notes, memoranda, correspondence, reports, papers, and publications. Perhaps the most noteworthy portion of their records would be the responses of individual states to a survey dealing with health care reform and tax law limitations. Usually someone associated with the attorney general's office of each respective state drafted answers to questions posed by the survey. There are also notes, outlines, and so forth utilized in the actual composition of the Clinton health care plan.

Staff and Office Files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2201) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
