Records that were responsive to this FOIA request were found in one collection area - Clinton Presidential Records: Staff and Office Files. As policy, Staff and Office Files

are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. Staff and Office files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2201) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (17 USC 101), which governs the making of photocopies or other reproductions of copyrighted material.

Provenance
