Summary

This collection consists Molly Brostrom's Domestic Policy Council files. Brostrom served as Senior Policy Analyst in the Domestic Policy Council from April 1995 to January 1997. She worked extensively in the areas such as: homelessness, housing, seniors, social security, veterans, and youth and family issues. Her records consist of agendas, articles, briefing papers, informational packets, letters, legislation, legislative referral memoranda, meeting notes, memos, reports, speech material, statements of administration policy, talking points, testimony, and weekly reports.

Molly Brostrom held a position as Senior Policy Analyst in the Domestic Policy Council from April 1995 to January 1997. She was assigned to work with very specific and overlapping areas of domestic policy involving homelessness, housing, seniors, social security, veterans, and youth and family issues. Areas of interest include accomplishments, assistance funding, base closure, budget and appropriations, economic development, education, homeless initiatives, Interagency Council on the Homeless, Interagency Veterans Policy Group, legislation, public housing, Social Security Advisory Council, and various White House conferences. The records include agendas, articles, briefing papers, informational packets, letters, legislation, legislative referral memoranda, meeting notes, memos, reports, speech material, statements of administration policy, talking points, testimony, and weekly reports.
