## **Summary**

This collection consists of presidential schedules for October 3- 4, 1993 and November 15-17, 1995. The records consist of correspondence, memoranda, reports, newspaper articles, and four presidential schedules. The topics covered include the government furlough, health care, the budget, and children with learning disabilities.

## **Scope and Content Note**

The materials in FOIA 2006-0314-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA request 2006-0314-F contains copies of some Presidential Schedules and material containing Presidential handwriting. The White House Office of Records Management (WHORM) Alpha Files contains no records relating to the specific schedules or handwriting that was requested. The WHORM Subject File Categories contains records pertaining to presidential handwriting for the specific days requested. The records include correspondence, memoranda, notes, news articles, and reports. There are thank you letters, notes, and staff correspondence pertaining to the budget, HealthCare, and the Government Furlough. There are newspaper articles and reports relating to children with learning disabilities. There were no handwritten records relating to Mogadishu for October 3-4, 1993. The White House Staff and Office Files contains copies of four Presidential Schedules. The Automated Records Management System (ARMS) Emails contains no records relating to the request. The NSC Cable, Email, and Records Management Systems contains no records relating to the request.

## **System of Arrangement**

Records that were responsive to this FOIA request were found in two collection areas – Clinton Presidential Records: WHORM-Subject File-General and Clinton Presidential Records: WJC Schedules. WHORM Subject and WHORM Alpha files are processed at the document level. The WHORM Subject file was compiled by the White House of Records Management and is a series of categories designated by a letter/number combination. A complete listing of the categories with detailed descriptions is provided in our research room. Please note that a single asterisk “\*” indicates that the category is entirely processed and open.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2201) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

## **Copyright**

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (17 USC 101), which governs the making of photocopies or other reproductions of copyrighted material.

## **Provenance**
