Approximately 134 photographs, in color film processed from 35mm negatives.

Summary

This collection consists of photographs of Hillary Clinton addressing the Redbook Magazine Awards luncheon on June 2, 1998, in the East Room of the White House. Kate White, Editor of Redbook, introduced each honoree at the luncheon. Hillary Clinton presented awards to the honorees and joined the award winners for a group photo. One of the honorees was Senator Patty Murray. Hillary Clinton greeted the event's participants in the Diplomatic Reception room. There are also photos of White House Pastry Chef, Roland Mesnier, Franette McCullough, and staff.

Scope and Content Note

The materials in FOIA 2008-0002-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Records that were responsive to this FOIA request were found in one collection area and one series— Clinton Presidential Records: Photographs of the White House Photograph Office, and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the incidental processing of photographs that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Freedom of Information Act (FOIA) (5 USC 552 as amended) and the Presidential Records Act (PRA) (44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Photographs in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (17 USC 101), which governs the making of photocopies or other reproductions of copyrighted material.
