The email contain records related to meetings, briefings, and travel regarding Rwanda, Zaire, Burundi, Nigeria, Gambia, Middle East, and China. The memoranda contains material regarding meetings, briefings, talking points, and reports related to Rwanda, Haiti, Israel, Russia, Bosnia, and the Space Station.
