Summary

This collection contains materials relating to the nomination of Judge Sonia Sotomayor to the U.S. Court of Appeals for the Second Circuit. President Clinton nominated Judge Sotomayor to the position in 1997, and she was confirmed by the Senate in 1998. The records contain biographical information, court opinions as Judge for the U.S. District Court for the Southern District of New York and letters in support of her nomination. As policy, Staff and Office files are processed at the folder level, meaning that individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2201, et seq.) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
