Summary

One of several positions held by Marjorie Tarmey within the Clinton White House was that of Executive Assistant to Ira Magaziner within the Office of Policy Development, part of the First Lady's Office, during the early years of the Administration. Topics highlighted in her collection include health care reform, office administration issues, White House interns, and veterans. The records in this collection include memoranda, resumes, notes, document drafts, articles, newsletters, correspondence, and applications.

Scope and Content Note

Marjorie Tarmey worked in the Office of Policy Development in the First Lady's Office, serving as the Executive Assistant to Ira Magaziner; she subsequently worked in the Deputy Chief of Staff's office. Before coming to the White House, she worked at the Department of Labor. After leaving the White House, she worked in the Office of Personnel Management as a deputy chief of staff, and currently works for Catapult Technology as a Project Manager. This collection highlights topics relating to health care reform, office administration, White House interns, and veterans. The records include memos, resumes, notes, drafts, articles, newsletters, correspondence, and applications.
