## **Summary**

This collection consists of records dealing with terrorist attacks during the Clinton Administration and the counterterrorism policies put in place in response to those attacks. These records include press briefings following the attack on the USS Cole and memos regarding security during the 1996 Olympic Games in Atlanta. Records dealing with aviation security include the final report to the President from the White House Commission on Aviation Safety and Security dated February 12, 1997, a list of accomplishments, and press guidance on increased security measures dated August 1995.

## **Scope and Content Note**

The materials in FOIA 2006-1164-F (segment 1) are a selective body of documents responsive to the topic of the FOIA . Researchers should consult the archivist about related materials. FOIA 2006-1164-F (segment 1) contains records dealing with terrorist attacks during the Clinton Administration and the counterterrorism policies put in place in response to those attacks. These records include press briefings following the attack on the USS Cole and memos regarding security during the 1996 Olympic Games in Atlanta. Records dealing with aviation security include the final report to the President from the White House Commission on Aviation Safety and Security dated February 12, 1997, a list of accomplishments, and press guidance on increased security measures dated August 1995. Other topics include the Omnibus Counterterrorism Act of 1995 and critical infrastructure protection. The White House Staff and Office files contain memos, reports, publications, and press briefings and guidance. These records can all be found in the National Security Council's Transnational Threats office. The majority of the records related to this FOIA case are closed for national security reasons.

**System of Arrangement**

Records that are responsive to this FOIA request were found in one collection area: Clinton Presidential Records: White House Staff and Office Files. Staff and Office files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity. Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

**Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2201) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

**Copyright**

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (17 USC, 101) which governs the making of photocopies or other reproductions of copyrighted material.

**Provenance**

Official records of William Jefferson Clinton's presidency are housed at the Clinton Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).
