Summary

This collection consists of correspondence regarding unidentified flying objects and extraterrestrials. Edgar Mitchell is a signatory on some of the correspondence to President Clinton from the Project Starlight Coalition.

Scope and Content Note

The materials in FOIA 2006-0490-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA request 2006-0490-F consists of correspondence from "The Project Starlight Coalition" to President Clinton and a response from James A. Dorskind, Special Assistant to the President/Director of Correspondence and Presidential Messages, regarding unidentified flying objects and extraterrestrials. WHORM Subject File FE010-01 contains a letter, dated June 4, 1995, to President Clinton from "The Project Starlight Coalition." Edgar Mitchell is one of many signatories on this letter. The file also contains a letter, dated August 3, 1995, from James A. Dorskind, to Steven M. Greer, M.D., Director, Center for the Study of Extraterrestrial Intelligence regarding unidentified flying objects and extraterrestrials. Accompanying this correspondence is the White House tracking sheet.

Records that were responsive to this FOIA request were found in one collection area—Clinton Presidential Records: WHORM Subject Files. WHORM Subject files are processed at the document level. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area. The WHORM Subject file was compiled by the White House Office of Records Management and is a series of categories designated by a letter/number combination. A complete listing of the categories with detailed descriptions is provided in our research room.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Freedom of Information Act (FOIA) (5 USC 552 as amended) and the Presidential Records Act (PRA) (44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.
