Summary

This collection consists of a detailed report of phone calls to or from President Clinton for each day between January 20, 1996 and February 10, 1996. The logs detail the date, time, location, and participants of the phone calls. In this specific date range, phone calls to or from various White House staff, advisors, senators, congressman, governors, mayors, Cabinet secretaries, and Foreign Heads of State are noted.

Scope and Content Note

The materials in FOIA 2012-0494-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA request 2012-0494-F consists of the detail report of the electronic daily diary for phone calls for each day between January 20, 1996 and February 10, 1996. The logs note phone calls to or from President Clinton detailing the date, time, location, and participants of the phone calls. In this specific date range, phone calls to or from various White House staff, advisors, senators, congressman, governors, mayors, Cabinet secretaries, and Foreign Heads of State are noted.

Records that are responsive to this FOIA request were found in this collection area – Electronic Daily Diary. Clinton Presidential Records relating to telephone logs consist of Electronic Daily Diary detail pages organized in chronological order. The White House Diary System (Electronic Daily Diary) logs the President’s incoming and outgoing telephone calls. The log details the date, time, location, and participants of the call.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2001) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (17 USC, 101) which governs the making of photocopies or other reproductions of copyrighted material.
