**Summary**

This collection contains records related to correspondence between President Clinton and President Mohammad Khatami of Iran. Khatami was elected in 1997 and remained President of Iran through 2005. Records include National Security Council profiles sheets, tracking sheets and email.

**Scope and Content Note**

The materials in FOIA 2007-0467-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA request 2007-0467-F contains records related to correspondence between President Clinton and President Mohammad Khatami of Iran. President Khatami was elected in 1997 and remained President of Iran through 2005. Records include National Security Council profiles sheets, tracking sheets and email. The majority of the records in this collection remain closed and unavailable for research for national security reasons

**System of Arrangement**

Records that are responsive to this FOIA request were found in these collection areas- Clinton Presidential Records: White House Staff and Office Files and Clinton Presidential Records: NSC Cable, Email and Records Management Systems. Staff and

Office files were maintained at the folder level by staff members within their individual offices and documents all levels of administration activity. Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2201) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

## **Copyright**

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (17 USC, 101) which governs the making of photocopies or other reproductions of copyrighted material.

## **Provenance**

Official records of William Jefferson Clinton's presidency are housed at the Clinton Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).
