In a meeting between McGeorge Bundy and Tony Lake, Bundy offered to be of assistance in any way he could. On the issue of CTB, the two agreed that when the time came, Bundy could and would help. Bundy further opined that with Drell on the PFIAB along with Crowe, the Administration should be insulated against criticism from the right, i.e., they would know that it was the labs who were asking for the tests more than the military more broadly. Of more concern was the left who would wonder why there needed to be any more testing at all in the transition from the moratorium to CTB. Tony asked that I pass this along to you.

Re: New PFIAB/ PIOB Executive Order

In anticipation of a phone call from Governor Jim Thompson, Will Itoh asked that I provide you with note on our proposed merger of the President's Intelligence Oversight Board (PIOB) into his Foreign Intelligence Advisory Board.

The President has before him a new draft executive order which would abolish the President's Intelligence Oversight Board (PIOB) and preserve its function by making the PIOB a standing Committee of the President's Foreign Intelligence Advisory Board (PFIAB). The Order has not been signed.

The draft requires Inspectors General and General Counsels to report to the IOB "at least on a quarterly basis and from time to time as necessary or appropriate." The current order provides only that they "shall report". The strengthening of the reporting requirement will counterbalance the argument that the PIOB and its functions are being weakened by the loss of the Board's independent status.

In addition, we believe that the IOB's oversight role will also be strengthened by having its members fully fluent in the full range of intelligence issues being reviewed by the PFIAB.

The draft provides that the Chairman and other members of the IOB are to be appointed by the Chairman of the PFIAB. The current order provides that they "shall be appointed by the President."

The draft provides that the IOB is to report to the President "through the Chairman of the PFIAB".
