#### Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2201) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (17 USC, 101) which governs the making of photocopies or other reproductions of copyrighted material.

#### Provenance

Official records of William Jefferson Clinton's presidency are housed at the Clinton Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### Processed by

#### Scope and Content

The materials in FOIA 2006-0885-F (segment 6) are a selective body of documents responsive to the topic of the FOIA. Additional material for this FOIA case has been processed in segments 1-5.

FOIA 2006-0885-F (segment 6) contains records of the Clinton Administration's efforts to overhaul the health care system in the United States. This segment is comprised of records from Jack Lew and Lynn Margherio. One can find notes, memoranda, papers, reports, newspaper and magazine articles, handwritten notes, press releases, drafts of discussions, speeches, and bills, faxes, fax cover sheets, pamphlets, and books.

Jack Lew started out in 1993 as a Special Assistant to the President under President Clinton. Most of the records in the collection are devoted to figuring out the numerical and budget aspects of transforming health care in the United States. Detailed graphs showing the cost of premium discounts, alternative deficits for 1993-2000, and federal spending for Medicaid, preliminary drafts discussing legislative strategy, and memoranda listing options for Department of Energy and Commerce analysis requests can

be located throughout the documents. Lew also apparently played a substantive role in drafting language for WIC (Women, Infants, and Children).

Lynn Margherio, Senior Policy Analyst for the Domestic Policy Council, advised President Clinton on health care reform in 1993 and 1994. The Staff and Office Files of Lynn Margherio consist of graphs, charts, articles in scholarly journals and daily newspapers, handwritten notes, memoranda, notes, papers, books, correspondence, reports, schedules, and agendas. The specificity of some of the material is best exemplified by titles such as "The Appropriateness of Use of Coronary Artery Bypass Graft Surgery in New York State." In addition, there is a book entitled *Well-Healed: Inside Lobbying for Health Care Reform* which is published by the Center for Public Integrity. Managed competition is a well-covered topic in these documents, with state and company health care plans being featured prominently.

Another segment of the Staff and Office Files of Lynn Margherio consist of Lexis-Nexis articles, resumes, notes, publications, speeches, scholarly articles, graphs, lists, correspondence, note cards, and drafts largely dealing with individuals (doctors in the main) who might be enlisted in activities in support of President Clinton's health care plan. Many of these people were succinctly characterized with respect to their position on that issue (to what extent they favored the Health Security Act of 1993 and whether or not they would speak in favor of the legislation) and in some cases put down for addresses before influential organizations. A few assumed posts of significance within the Health Care Task Force. For instance, Robert A. Berenson was appointed Chairman of the Malpractice Working Group.

### **System of Arrangement**

Records that were responsive to this FOIA request were found in one collection area—Clinton Presidential Records: White House Staff and Office Files.

Staff and Office Files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

In the Staff and Office Files of Lynn Margherio and Jack Lew there were several 3 1/2" diskettes containing memoranda, reports, lists, agendas, correspondence, papers, and other similar records. The materials from these diskettes have been processed electronically and are available for research in an electronic format.
