FOIA case 2011-0426-F contains responsive photos from the White House Photograph Office.

The photographs processed for this request pertain to the late 1995 and early 1996 budget meetings at the White House involving, President Clinton, Vice President Al Gore, Sec. Robert Rubin, Sen. Bob Dole, Rep. Newt Gingrich, Rep. Dick Armey, Sen. Tom Daschle, Rep. Richard Gephardt, Leon Panetta, and others. The meetings at the White House were negotiations to solve the budget impasse and government shutdown.
