Extent

Approximately 1,814 photographs in color and black & white film processed from 35mm negatives.

Scope and Content

FOIA 2016-0984-F (Segment 80) is a request for all Clinton Administration White House photographs taken from January 1, 1994 through December 31, 1994.

The photographs processed in this segment were created on August 10, 1994 through August 15, 1994. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Select material responsive to this segment was previously processed in FOIA case numbers 2016-0871-F & 2022-0237-F.

Photographs from August 15, 1994 are as follows:

President William Jefferson Clinton meets in the Oval Office of the White House with Linda Lader, Phil Lader, and Alexis Herman. Later the President speaks on the telephone to Prime Minister Paul Keating of Australia. Present is Andrew Friendly.

President William Jefferson Clinton addresses a Crime Bill Highlights event in the Rose Garden of the White House. Present includes Dewey Stokes, Marc Klaas, Steven Sposato, Janice Payne, and police officers, among others. Prior to the event the President confers with event guests in the Oval Office.

First Lady Hillary Rodham Clinton addresses a national service meeting in the Indian Treaty Room of the White House. Present is Eli Segal, among others. Later the First lady proceeds to the Grand Hyatt Hotel in Washington, DC to deliver an address at an event titled "Solving Youth Violence: Partnerships that Work." Present includes Secretary of Education Richard Riley and Deborah Prothrow-Stith, among others.

Photographs from August 16, 1994 are as follows:

President William Jefferson Clinton jogs on The Mall in Washington, DC.

President William Jefferson Clinton and Vice President Albert Gore, Jr. meet with Representative Clo Fields in the Oval Office of the White House. Also present a Leon Panetta, Lloyd Cutler, Pat Griffin, and George Stephanopoulos.

President William Jefferson Clinton greets Melissa Etheridge, Eleanor Mondale, and guests in the Oval Office of the White House. Also present is Vice President Albert Gore, Jr., who joins the group. Later the President greets Catherine Cornelius. Also present is Stephanie Streett.

President William Jefferson Clinton drops by the swearing-in reception in the Indian Treaty Room of the White House for George Bruno as the United States Ambassador to Belize

President William Jefferson Clinton meets with House Republicans in the Cabinet Room of the White House regarding the Crime Bill. Participants include Vice President Albert Gore, Jr., Lloyd Cutler, New Gingrich, Fred Grandy, Representative Connie Morella, Jim Ramstad, and George Stephanopoulos. Also photographed is Dan Poneman.

President William Jefferson Clinton greets staff & White House interns in the Old Executive Office Building & Phil Lader's office.

President William Jefferson Clinton greets Edwin Colon and Pearlie Myers outside the West Wing in the White House. Later the President greets Phil Lader.

Present includes Vice President Albert Gore, Jr., Representative Charles Rangel, Representative John Lewis, Representative Maxine Waters, Leon Panetta, Lorraine Miller, Alexis Herman, Pat Griffin, and George Stephanopoulos.

First Lady Hillary Rodham Clinton attends a "Kids Speak Out" event in the Russell Building Senate Caucus Room on Capitol Hill. Present includes Senator Chris Dodd, Senator Don Riegel, Secretary of the Treasury Lloyd Bentsen, Asha Thume, Jessica Wright, Ian Cook, Jennifer Bush, Kathy Bush, and Rakia Reeves, among others.

Photographs from August 18, 1994 are as follows:

President William Jefferson Clinton jogs along the Potomac River with Representative Tom Barrett and Representative Peter Barca.
