All Presidential series photographs from the Clinton Administration taken on August 26, 1994 through September 2, 1994.

#### **Extent**

Approximately 2,202 photographs in color and black & white film processed from 35mm negatives.

#### Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Scope and Content**

FOIA 2016-0984-F (Segment 82) is a request for all Clinton Administration White House photographs taken from January 1, 1994 through December 31, 1994.

The photographs processed in this segment were created on August 26, 1994 through September 2, 1994. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed.

# Photographs from August 26, 1994 are as follows:

President William Jefferson Clinton jogs on the Mall in Washington, DC.

President William Jefferson Clinton meets in the Cabinet Room of the White House with the Presidential Business Development Mission to Beijing, Shanghai, Guangzhou, and Hong Kong. Present includes Secretary of Commerce Ron Brown and Steve Silverman, among others.

President William Jefferson Clinton and Vice President Albert Gore, Jr., meet in the Oval Office of the White House. Also photographed is General John Shalikashvili and Strobe Talbott speaking on the telephone in the Outer Oval Office.

President William Jefferson Clinton signs the Crime Bill in the Oval Office of the White House. Also present are Senator George Mitchell & Senator Earnest Hollings.

President William Jefferson Clinton meets with staff in the Oval Office Dining Room at the White House. Present includes Vice President Albert Gore, Jr., Leon Panetta, Robert Rubin, Carol Rasco, Jack Quinn, Gene Sperling, George Stephanopoulos, and Kumiki Gibson (Chief Counsel of the Vice President).

President William Jefferson Clinton meets with staff in the Oval Office Dining Room and converses with the press in the Oval Office regarding the Crime Bill. The President and Attorney General Reno converse on the telephone with mayors who back the Crime Bill. Photographed includes Vice President Albert Gore, Jr., Attorney General Janet Reno, Leon Panetta, Marcia Hale, George Stephanopoulos, Mark Gearan, Samuel "Sandy" Berger, Harold Ickes, Josh King, Ron Klain, Rahm Emanuel, Jonathan Price, and Margaret Jane "Dee Dee" Myers. The President converses with Pat Griffin, Attorney General Reno and George Stephanopoulos in a separate meeting.

President William Jefferson Clinton meets in the Outer Oval Office Dining Room regarding the Crime Bill. Present includes Senator George Mitchell, Leon Panetta, Harold Ickes, Pat Griffin, and George Stephanopoulos. The President holds a golf putter while seated.

President William Jefferson Clinton delivers his weekly radio address in the Roosevelt Room of the White House. Following the address the President greets guests.

President William Jefferson Clinton stops by the White House Mess and greets guests.

President William Jefferson Clinton confers with George Stephanopoulos, Mark Gearan, Rahm Emanual, Jonathan Prince, and Nancy Hernreich prior to departing for Martha's Vineyard. Also photographed are Betty Currie, Thomas "Mack" McLarty, Wendy Smith, and Margaret Jane "Dee Dee" Myers. The President, First Lady Hillary Rodham Clinton, and Chelsea Clinton proceed to Marine One and depart en route Martha's Vineyard. The Clintons arrive at Martha's Vineyard and greet guests including Vernon Jordan.

First Lady Hillary Rodham Clinton meets with Yvonne Pine and Alice Pushkar in the Map Room of the White House. Also photographed is Socks the Cat outside of the West Wing.

# Photographs from August 28, 1994 are as follows:

President William Jefferson Clinton and First Lady Hillary Rodham Clinton are photographed outside a church in Oak Bluffs in Martha's Vineyard. The President and First Lady converse with guests.

President William Jefferson Clinton, Hillary Rodham Clinton, and Chelsea Clinton sail aboard Zara in Martha's Vineyard. Also photographed is James Taylor, among others.

President William Jefferson Clinton golfs at Farm Neck golf club in Martha's Vineyard. Present is Vernon Jordan, George Stevens, Jr, and Paul Glaser. Also photographed is a gallery of guests and the press pool at the course. Later the President converses on a telephone with Vice President Albert Gore, Jr.

# Photographs from August 30, 1994 are as follows:

President William Jefferson Clinton golfs at Mink Meadows golf course in Martha's Vineyard. Present are Vernon Jordan, David Schulte, and Mayor Dennis Archer.

#### Photographs from August 31, 1994 are as follows:

President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Chelsea Clinton bike to Edgartown and Oak Bluffs on Martha's Vineyard. The President and First Lady stop at the Steamship Authority and the Wesley Hotel (Now known as Summercamp) in Oak Bluffs. The Clintons greet people around town and guests present at the hotel. The Clintons walk around town and stop into Espresso Love café. Afterwards the Clintons proceed down to the Edgartown docks.

President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Chelsea Clinton play miniature golf at Island Cove mini golf in Martha's Vineyard.

President William Jefferson Clinton and First Lady Hillary Rodham Clinton purchase chocolates at a shop in Martha's Vineyard.

President William Jefferson Clinton and Chelsea Clinton ride horses along the beach on Martha's Vineyard.

#### Photographs from September 1, 1994 are as follows:

President William Jefferson Clinton golf at Farm Neck golf course in Martha's Vineyard. Present includes Claire O'Callahan, Mauri Flanagan, and Robert Flanagan.

President William Jefferson Clinton and First Lady Hillary Rodham Clinton visit guests at Gay Head beach in Martha's Vineyard.

# Photographs from September 2, 1994 are as follows:

President William Jefferson Clinton meets with Deputy Prime Minister Dick Spring of Ireland in Martha's Vineyard. The President and Deputy Prime Minister discuss the Irish Republican Army cease-fire in Northern Ireland. Also photographed is Margaret Jane "Dee Dee" Myers outside with the President.

President William Jefferson Clinton departs the property of Senator John Kerry on Martha's Vineyard.

# **System of Arrangement**

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level.
