Approximately 1,842 photographs in color and black & white film processed from 35mm negatives.

Scope and Content

FOIA 2016-0984-F (Segment 81) is a request for all Clinton Administration White House photographs taken August 19, 1994, through August 25, 1994. Numerous photo contact sheets from August 19, 1994, were previously processed in cases 2016-0871-F, 2019-0387-F, and 2022-0237-F.

The Clinton Presidential records to be opened consist of photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, official phone calls, photo-ops, etc. involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Photographs proposed to be released from August 19, 1994, are as follows:

President Clinton greets his brother Roger Clinton and his band members in the Oval Office. President Clinton talks with David Crosby, Stephen Stills, Graham Nash, and others in the Oval Office.

President Clinton participates in a press conference in the East Room.

President Clinton greets the Edwards and McGregor families in the Oval Office.

Betty Currie and Wendy Smith hold Socks the cat in the Outer Oval Office.

Photographs proposed to be released from August 20, 1994, are as follows:

President Clinton goes golfing at Army-Navy Country Club in Arlington, Virginia with Tony Rodham, Nicole Rodham, and others.

President Clinton delivers his weekly radio address in the Oval Office.

Ricki Seidman, Janet Gilmore, and Jimmie Gilmore pose for photos at the podium in the Press Briefing Room.

Photographs proposed to be released from August 21, 1994, are as follows:

President Clinton goes jogging across the 14th Street Bridge in Washington, D.C and along the George Washington Parkway area on the Virginia side of the Potomac River. President Clinton returns to the White House after jogging.

President Clinton confers with staff regarding the Crime Bill in the Oval Office Dining Room, Study, and Oval Office. Included are Mark Gearan, Marcia Hale, David Dreyer, Jonathan Prince, Bruce Reed, Stan Greenberg, George Stephanopoulos, Dee Dee Myers, Leon Panetta, Harold Ickes, Rahm Emanuel, and Josh King. President Clinton makes a statement to the press in the Oval Office regarding the passage of the Crime Bill.

Photographs proposed to be released from August 22, 1994, are as follows:

President Clinton meets with Chief Executive Officers in the Oval Office. Alexis Herman and Mack McLarty are present at the meeting.

President Clinton meets with Carol Rasco an AIDS Policy coordinator in the Oval Office.

Photographs proposed to be released from August 23, 1994, are as follows:

President Clintons goes jogging on the National Mall in Washington.

President Clinton models a "Friends of Jennifer T-Shirt" in the Oval Office.

President Clinton participates in a breakfast meeting union representatives in the Map Room. Harold Ickes is present at the meeting.

Mack McLarty greets an intern in the West Wing.

President Clinton participates in a signing ceremony in the Rose Garden for H.R. 1933, The Martin Luther King Holiday and Service Act of 1994. Ceremony participants include Martin Luther King III, Senator Harris Wofford, and Representative John Lewis. Prior to the signing, the President meets in the Oval Office with Vice President Albert Gore, Leon Panetta, George Stephanopoulos, Dee Dee Myers, Lorraine Miller, Alan Stone, and Bruce Reed.

First Lady Hillary Rodham Clinton greets Los Angeles Times reporter Jack Nelson in the Map Room. The First Lady greets Time Magazine reporter Margaret Carlson in the Map Room.

President Clinton meets in the Cabinet Room with Vice President Albert Gore, Attorney General Janet Reno, Strobe Talbott, Secretary William Perry, John Deutch, Madeleine Albright, Leon Panetta, Leon Fuerth, Peter Tarnoff, Pat Griffin, and others regarding the U.S. policy towards Cuban immigration.

Mack McLarty greets staff including Janine Stanzione, Kimberly Cain, and Karen Ewing in the West Wing.

President Clinton tapes a message using a hand-held microphone in the Oval Office. Richard Strauss sits next to the President.

Photographs proposed to be released from August 23, 1994, Continued:

President Clinton meets with reporters and editors including Meg Greenfield on the White House Patio and they visit the Oval Office Study and Oval Office Dining Room.

Photographs proposed to be released from August 24, 1994, are as follows:

President Clinton jogs past the sculpture “The Awakening” at Hains Point in Washington D.C..

President Clinton participates in an International Literacy Day signing ceremony in the Oval Office. Representatives from the American Literacy Council and Senator Paul Simon are present at the ceremony.

President Clinton and First Lady Hillary Rodham Clinton participate in an interview with Carl Anthony, American Heritage Magazine, in the Oval Office.

President Clinton receives the President’s Public Papers from the Federal Register, National Archives staff including Acting Archivist Trudy Peterson, Richard Claypoole, and others in the Oval Office.

President Clinton participates in a radio interview with Gene Burns and “Talkers” on WOR Radio in Room 415 of the Old Executive Office Building (OEOB). President Clinton is also interviewed by Michael Harrison. President Clinton greets staff and volunteers in the Old Executive Office Building hallway.

President Clinton participates in a satellite feed to the B’nai B’rith Convention in Room 459 of the Old Executive Office Building.

President Clinton participates in a briefing in the Oval Office with George Stephanopoulos, Martin Indyk, Dee Dee Myers, Bruce Reed, Sandy Berger, Nancy Hrenreich, and others.

President Clinton goes golfing at East Potomac Park, Hains Point in Washington.

Photographs proposed to be released from August 25, 1994, are as follows:

President Clinton goes jogging near the U.S. Capitol, the Lincoln Memorial, and Reflecting Pool area.

Photographs proposed to be released from August 25, 1994, Continued:

President Clinton meets with Secretary Ron Brown, Mack McLarty, Bowman Cutter, and others in the Oval Office.

President Clinton meets in the Oval Office with Mark Gearan and Don Baer regarding an upcoming speech.

President Clinton signs H.R. 4812 in the Oval Office as Senator Barbara Boxer watches. Then President jokes with Vice President Albert Gore, Stew Boxer, Leon Panetta, and others.

President Clinton watches the Crime Bill vote take place in the Senate on television in the Outer Oval Office with Eli Segal, Wendy Amith, Rick Allen, Betty Currie, Leon Panetta, Dee Dee Myers, Nancy Hernreich, Rahm Emanuel, Josh King, and others. President Clinton makes a statement to the press in the Rose Garden regarding the 61-39 Senate vote for the passage of the Crime Bill.

President Clinton participates in an interview with USA Today Weekend in the Oval Office. Eli Segal and Rick Allen are present during the interview.

Betty Currie talks with Stephanie Streett and Wendy Smith in the Outer Oval Office. Erskine Bowles and Victoria Radd are present in the office.

President Clinton sits at his desk in the Oval Office and talks on the telephone.

President Clinton talks with Pat Griffin and George Stephanopoulos in the Oval Office.

President Clinton shows reporters including Helen Thomas his campaign button and political memorabilia collection in the Oval Office hallway. President Clinton participates in an interview with reporters on the White House Patio. Dee Dee Myers and George Stephanopoulos are present at the interview.

President Clinton meets alone with Sandy Berger in the Oval Office.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level.

While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
