Scope and Content

FOIA 2016-0984-F (Segment 83) is a request for all Clinton Administration White House photographs taken August 31, 1994, through September 8, 1994. Photo contact sheets from September 1, 1994, were previously processed in cases 2016-0871-F & 2007-1756-F.

The Clinton Presidential records to be opened consist of photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, official phone calls, photo-ops, etc. involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Photographs from August 31, 1994, are as follows:

President Clinton, First Lady Hillary Rodham Clinton, and Chelsea Clinton, and others play miniature golf on Martha's Vineyard, Massachusetts.

Photographs from September 3, 1994, are as follows:

President Clinton and First Lady Hillary Rodham Clinton paddle a canoe on Oyster Pond on Martha's Vineyard. The Clintons ride in a small motorboat with Chelsea Clinton and her friend. The Clintons have a picnic on the beach with friends. President Clinton assists the First Lady and Chelsea rig a small sailboat.

President Clinton delivers his weekly radio address from an elementary school on Martha's Vineyard. President Clinton and First Lady Hillary Rodham Clinton greet radio address guests.

President Clinton and First Lady Hillary Rodham Clinton greet Richard Friedman's neighbors. The Clintons are staying at the Friedman residence on Martha's Vineyard.

President Clinton and First Lady Hillary Rodham visit the Bickerton & Ripley bookstore and visit a deli shop on Martha's Vineyard.

President Clinton and First Lady Hillary Rodham Clinton pet Henrietta the pig at the Richard Friedman residence on Martha's Vineyard.

Photographs from September 4, 1994, are as follows:

President Clinton golfs with Vernon Jordan at Mink Meadows golf course on Martha's Vineyard.

President Clinton and First Lady Hillary Rodham Clinton arrive at Black Dog Tavern on Martha's Vineyard and greet patrons and restaurant personnel. The Clintons depart from the tavern and greet people outside the restaurant.

Photographs from September 4, 1994, Continued:

President Clinton, Hillary Rodham Clinton, Chelsea Clinton, and friends arrive at Union Chapel on Martha's Vineyard to attend church services.

Photographs from September 5, 1994, are as follows:

President Clinton, Chelsea Clinton and her friend visit Mad Martha's Ice Cream on Martha's Vineyard.

President Clinton and First Lady Hillary Rodham Clinton attend a synagogue service on Martha's Vineyard. The Clintons are seated with Alan Dershowitz and family.

President Clinton greets a girl seated in a wheelchair sponsored by "Make-A-Wish." President Clinton departs Martha's Vineyard to travel to Bath, Maine. President Clinton reads during the flight.

President Clinton arrives at the airport in Bath. He is met by Senator George Mitchell and others at the airport.

President Clinton addresses employees at the Bath Ironworks. The President wears an AFL_CIO Union hat and jacket during his speech. President Clinton tours the USS Laboon. President Clinton greets union workers prior to departing Bath.

President Clinton and First Lady Hillary Rodham Clinton golf with Vernon Jordan and Ann Jordan at Mink Meadows golf course on Martha's Vineyard.

Photographs from September 6, 1994, are as follows:

President Clinton greets Chef Charles Charbonneau and White House Stewards at the Richard Friedman residence on Martha's Vineyard.

President Clinton and First Lady Hillary Rodham go for a boat ride on Oyster Pond on Martha's Vineyard.

Photographs from September 6, 1994, Continued:

President Clinton talks on a portable telephone and talks to President Carlos Salinas of Mexico. The President is accompanied on the Martha's Vineyard beach by military aide Leo Mercado.

Photographs from September 7, 1994, are as follows:

President Clinton and Hillary Rodham Clinton ride bicycles on Martha's Vineyard. The Press Pool covers the bike ride.

President Clinton visits the Scott Family prior to departing the Richard Friedman residence on Martha's Vineyard.

President Clinton and First Lady Hillary Rodham Clinton participate in a radio interview at the airport on Martha's Vineyard.

President Clinton and First Lady Hillary Rodham Clinton greet people at the airport prior to departing Martha's Vineyard.

President Clinton and First Lady Hillary Rodham Clinton arrive on the South Lawn aboard Marine One on their return from Martha's Vineyard.

President Clinton participates in a foreign policy meeting regarding Haiti in the Cabinet Room. Meeting participants include Vice President Albert Gore, Gen. John Shalikashvili, Secretary Warren Christopher, Secretary William Perry, Madeleine Albright, John Deutch, Leon Panetta, Leon Fuerth, Sandy Berger, David Gergen, Tony Lake, George Stephanopoulos, Strobe Talbott, William Studeman, and others.

President Clinton greets Betty Currie and Nancy Hernreich in the Outer Oval Office. President Clinton reviews documents with Nancy Hernreich. President Clinton talks alone with Madeleine Albright in the Outer Oval Office. President Clinton talks with Vice President Albert Gore, Leon Panetta, Tony Lake, and Secretary William Perry in the Outer Oval Office.

President Clinton and Hillary Rodham Clinton talk with Betty Currie, Nancy Hernreich, and Ricki Seidman in the Outer Oval Office. The Clintons exit the West Wing and walk to Blair House. The First Lady walks with Loretta Avent.

Photographs from September 8, 1994, are as follows:

President Clinton walks from Blair House to the White House. The President is accompanied by Andrew Friendly. The Clintons are staying at Blair House while the White House residence heating and cooling systems are being renovated.

President Clinton and Vice President Albert Gore address a breakfast for religious and community leaders in the State Dining Room. President Clinton greets participants individually.

President Clinton talks in the Outer Oval Office to Betty Currie and Nancy Hernreich.

President Clinton meets in the Oval Office regarding Haiti with Vice President Albert Gore, Tony Lake, Sandy Berger, Leon Fuerth, and others.

President Clinton meets with South Korean Foreign Minister Han in Tony Lake's office in the West Wing.

President Clinton addresses the All-America Cities award ceremony in the Rose Garden. Participants include John Gardner, Chairman of the National Civic League and Wayne Hedien, Chairman of Allstate Insurance. The President presents plaques to the recipients.

President Clinton meets in the Oval Office with Vice President Albert Gore, Robert Rubin, and George Stephanopoulos.

White House Photographer Bob McNeely celebrates his birthday with White House Photo Office staff and his family in the West Wing.

President Clinton greets Dee Dee Myers in the West Wing.

President Clinton talks alone with Stephanie Streett in the Outer Oval Office.

President Clinton meets with Senator Orrin Hatch and others in the Oval Office.

President Clinton meets with Vice President Albert Gore, Alexis Herman, and others in the Oval Office.

Photographs from September 8, 1994, Continued:

President Clinton confers with George Stephanopoulos, Marcia Hale, and Loretta Avent in the Oval Office. President Clinton jokes with Marcia Hale, Loretta Avent, Betty Currie, Kelly Crawford, and Nancy Hernreich in the Outer Oval Office. President Clinton reads a newspaper in the Outer Oval Office.

President Clinton talks on the telephone in the Oval Office to President Eduardo Frei of Chile.

President Clinton walks towards Blair House with Chelsea Clinton.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level.

While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
