### **All Presidential Series Photographs of a Meet & Greet With President-Elect Hugo Chavez at the White House on January 27, 1999**

#### **Extent**

Approximately 100 photographs in color film processed from 35mm negatives.

#### **Access**

#### **Scope and Content**

FOIA 2024-0770-F is a request for all Clinton Administration White House photographs related to a meet & greet at the White House with President-elect Hugo Chavez of Venezuela. President-elect Chavez came to the White House on January 27, 1999, and President William Jefferson Clinton met with President-elect Chavez in Samuel "Sandy" Berger's office. Also photographed includes Vice President Albert Gore, Jr., Jim Dobbins, Gene Sperling, Ambassador Felix Rohatyn, Larry Summers, Robert Rubin, Lynn Culter, Doug Sosnik, and Representative Norman Dicks, among others.

#### **System of Arrangement**

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
