The photographs processed for this request pertain to President Clinton and Charlie Robertson at the OPSAIL 2000 event on July 4, 2000. The photographs contain President Clinton with Charlie Robertson, Chairman OPSAIL 2000, and others at the OPSAIL 2000 event on July 4, 2000 in New York City harbor. The photographs show President Clinton addressing the event aboard the U.S.S. John F. Kennedy, and President Clinton, Hillary Rodham Clinton, Chelsea Clinton and Charlie Robertson observing entertainment and dignitaries at the event. The President and dignitaries observe flyovers and a parade of tall ships at the event.
