PLEASE PASS TO SANDY AND DON FROM WEISS/CAMP/KURTZ (NOT TIME-SENSITIVE)

Trubnikov and his team had two days of meetings hosted by Tom Pickering on Afghanistan earlier this week, pursuant to the Moscow summit initiative. There were no surprises, and the Russians were well-behaved. We issued a noncontroversial joint press statement, which has been picked up by the wires today.

The Russians did not go overboard in trying to suck us into a discussion of Chechnya and stayed focused on practical issues such as a new round of UNSC sanctions against the Taliban. There was general agreement on the elements for a new UNSCR (travel ban, closure of Taliban offices abroad, nonhumanitarian flight ban, etc.), but the Russians were balky on an arms embargo, citing verification problems. We agreed on a joint diplomatic strategy in New York with other Perm Five and the NAM. (We'll see how much of this arrangement holds when it's briefed to the notoriously independent Sergey Lavrov ...)

Finally, the Russians made a pitch to expand the working group's focus to address global terrorism. Pickering leaned way forward and agreed to the proposal, but backpedaled a bit at the urging of Sestanovich and Weiss. We will be able to fix this glitch during State's drafting of a joint report from MKA and FM Ivanov which could be presented to the Presidents in New York.

Sanctions/Further UN Measures

I. Agreed Elements

- Ban travel by leading Taliban officials (possibly as defined by UNITA sanctions); suspend or cancel all travel documents, visas, or residence permits issued to these officials (except for purposes of travel to promote the peace process, humanitarian assistance, or for medical treatment)
- Require immediate and complete closure of Taliban offices overseas
- Ban charter flights (with exemptions for humanitarian/Haj purposes)
- Call for closing all camps where terrorists are trained and for strict monitoring of such closures, including by both regular and challenge inspections
- Call on all member states to take appropriate measures to block the flow across their borders of narcotics, weapons, financing, and people associated with terrorism in Afghanistan
- Embargo shipments by all member states to Afghanistan of acetic anhydride and other precursor chemicals used to manufacture narcotics
- Explore feasibility of arms embargo and monitoring regimes; share assessments as soon as possible
- Freeze UBL assets
- Close Ariana offices overseas
- Work together in Committee on Sanctions to strengthen implementation of 1267

II. Strategy

- Each side to report the results of the Working Group deliberations to their respective UN missions and ask their missions to engage in discussions in New York and in capitals on how best to proceed
- U.S. and Russia will each approach the other Perm 5 members: China, France and UK*
- U.S. and Russia will work together in approaching non-Perm 5 members*
- U.S. and Russia will brief states in the region and others about the results of the meeting and the intent to pursue further measures in the Security Council*
- Target date for having passed new resolution should be one year anniversary of UNSCR 1267 (October 15)
- Preamble to new UNSCR to cover related issues (drugs, arms, human rights, et cetera) and to seek cooperation of neighboring and other states to stem flows
- The annual UNGA resolution on Afghanistan will include similar elements

III. Resolution Criteria for Taliban

- Stop support for international terrorism
- Stop safe havens
- Turn over those accused of terrorism to a place where they can be brought to justice
- Close camps providing terrorist training and make them subject to UN inspections

Increase bilateral information exchange concerning:

- Arms, money, and drug flows
- Number of camps, number of trainees, origin of trainees (within the bounds of the UN resolution)

* Talking points for these approaches/briefings to be coordinated by the two sides.

Contacts with the Taliban

- Agree to continue: need to consider venues
- Need to define message further (human rights, narcotics trafficking, peaceful resolution with Northern Alliance, training camps and harboring terrorists)

Relations with Northern Alliance

- U.S. to examine enhancing humanitarian aid through NGOs to areas under Northern Alliance
- Advocate greater UN role (e.g., earthquake response)

Public Affairs Strategy

- Focus on Taliban unpopularity/inability to govern
- Avoid identifying Islam in general as source of threat
- Condemn Taliban support for/reliance on drug trafficking
- Explore use of all available means of communications to reach the Afghan people, including Pushtun and Dari radio services

Outside parties

- Role of Pakistan, UAE, Saudi Arabia
- Turkmenistan strategy: demarche (either joint or parallel) regarding readout of working group meeting, concern over drugs, compliance with UNSCR 1267
- Engage, and provide support to, other Central Asian countries which face threat from Afghanistan
- Other possibilities: Turkey, Egypt, Jordan, Iran
- Donor community (Afghan Support Group): elicit further humanitarian support of peace settlement
- Work with Six Plus Two, including at high-level meeting at the UN in September (seek report from Francesc Vendrell to the Six Plus Two on activities of United Nations Special Mission to Afghanistan)

Counternarcotics

- Explore Arlachi proposal for special UNSCR session on Afghan drug production
- Push forward Six Plus Two Counternarcotics initiative towards adoption of a regional Action Plan and implementation
- Continue narcotics interdiction and security belt as interim steps (including continuing to increase the effectiveness of Russian Border Security Forces operating in Tajikistan and border forces in Central Asia); when circumstances warrant, explore other economic alternatives for Afghan people and encourage donor community to support
- Both countries to use their influence to increase donor community support to Central Asian republics, Iran, and Pakistan
- U.S. requests point of contact on Russian side for all narcotics issues, including Afghanistan and Six Plus Two

UN Conventions/Multilateral Efforts

- Work practical measures to implement Terrorist Financing Convention (explore money laundering measures, G-8 demarches)
- Support Nuclear Terrorist Convention during special session of UN Committee on Counterterrorism (September)
- Enhance G-8 efforts
- Increase multilateral exchanges of information on terrorists and their activities in Afghanistan

Next Meeting of Working Group

- U.S. and Russia to explore meeting in Moscow in second week of October
- Delegations to recommend to Ministers they should consider broadening scope of Working Group in next meeting to cover terrorism in other parts of the world

is now seeking to delay the EO until next Tuesday in order to prepare the ground better: consult with selected members of Congress, ensure that adequate warnings and advisories are in place for U.S., UN and NGO personnel in the area, and to arm posts with background and talking points on the EO for use immediately after it is posted. We are told by Mike Sheehan now that she wants to talk to you about this.

These
measures can be taken well in advance of the Friday deadline, however, and the sooner we move, the more determination we signal to the Taliban and the Pakistanis. Dick therefore recommends that we stick to the current Friday target, which would allow us time to brief Sharif, pre-consult on the Hill, prepare for the security implications of the EO, and produce a good roll-out package--without unnecessary delay.
