Scope and Content

The materials in FOIA 2016-0834-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material.

FOIA request 2016-0834-F contains photographs from the Mayors and Law Enforcement Awards event on the South Lawn of the White House on April 14th, 1994. President William Jefferson Clinton delivers a speech and then presents the awards. Included are photographs prior to the event in the Diplomatic Reception Room. Key individuals include Mayor Jerry Abramson, President of the United States Conference of Mayors, Mayor Sharpe James, Mayor Richard Daley, and Mayor Richard Riordan, among others.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact

sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the incidental processing of photographs that are not wholly responsive to the subject area.
