Approximately 2,076 photographs in color and black & white film processed from 35mm negatives and born digital images.

#### **Scope and Content**

FOIA 2008-0666-F (Segment 21) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000.

The photographs processed in this segment were created from August 14, 2000; October 11, 2000 through October 17, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, staff and others for the time period processed.
