**All Presidential series photographs from the Clinton Administration taken November 13, 2000 through November 17, 2000.**

### **Extent**

Approximately 2,575 photographs in color and black & white film processed from 35mm negatives and born-digital files.

### **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

### **Scope and Content**

FOIA 2008-0666-F (Segment 29) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000.

The photographs processed in this segment were created from November 13, 2000 through November 17, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, staff and others for the time period processed.

Of particular focus is a trip overseas to Brunei and Vietnam for the Asia-Pacific Economic Cooperation (APEC) 2000 Summit, and a trip to Israel for the funeral of Leah Rabin. Many images of the APEC Summit were processed in another FOIA case # 2017-0508-F.

## **System of Arrangement**
