Scope and Content

FOIA 2008-0666-F (Segment 6) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000.

The photographs processed in this segment were created from July 7 2000, and July 27, 2000 through July 31, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, staff and others for the time period processed.

Photographs from July 27, 2000 are as follows:

President William Jefferson Clinton participates in a Congressional Picnic event at the White House. Present are John Podesta, Greta Van Sustern, Gary Walters & family, Representative Marion Berry & family, actor Chevy Chase, and Nancy Hernreich, among others. The President greets staff and people in attendance in various settings both inside and outside the White House.

President William Jefferson Clinton greets Chris Jennings and family in the West Garden Room at the White House.

President William Jefferson Clinton greets Jim Steinberg and family in the Oval Office.

President William Jefferson Clinton participates in an interview for an Israeli television reporter.

President William Jefferson Clinton delivers remarks on the Democratic Legislative Agenda in the Rose Garden at the White House. Present are Debbie Boudoulvas (student at George Washington University), Senators Tom Daschle, Daniel Akaka, Ted Kennedy, Representatives Richard Gephardt, Lynn Woolesy, Patrick Kennedy, Paul Kanjorski, Patsy Mink, Bob Filner, Benjamin Cardin, Chaka Fattah, Brad Sherman, William Jefferson, Tom Lantos, and Sheila Jackson Lee. Staff present are John Podesta and Gene Sperling.

President William Jefferson Clinton meets with President Joseph Estrada of the Philippines at the White House. Present include William Cohen, Larry Summers, Charlene Barshefsky, John Podesta, Gene Sperling, and Lael Brainard, among others. President Clinton gives President Estrada a tour of the White House. Also greeted are Dr. Connie Mariano, and Representatives Robert Underwood & Bob Filner. President Clinton, President Estrada, and the Filipino delegation pose for a group photograph at the West Wing porte-cochere entrance.

Photographs from July 28, 2000 are as follows:

President William Jefferson Clinton delivers remarks to the Boys' and Girls' Nation.

President William Jefferson Clinton participates in a videotaping session in the Cabinet Room at the White House.

President William Jefferson Clinton departs for Rhode Island via Air Force One from Andrews Air Force Base. Present are Senators Jack Reed, Ted Kennedy & Mrs. Vicki Kennedy, and Representative Patrick Kennedy, among others. The President arrives in Rhode Island and delivers a statement on the tarmac.

President William Jefferson Clinton tapes his weekly radio address in Rhode Island

President William Jefferson Clinton greets drivers and staff at two different locations in both Massachusetts and Rhode Island.

President William Jefferson Clinton departs Boston, Massachusetts via Air Force One en route to Andrews Air Force Base.

Photographs from July 29, 2000 are as follows:

President William Jefferson Clinton delivers remarks at the annual staff picnic. The President greets performers and individuals in attendance.

President William Jefferson Clinton & First Lady Hillary Rodham Clinton arrive at Andrews Air Force Base aboard Marine One. They depart for New York City, New York. The President and First Lady arrive at LaGuardia Airport. They proceed to the Waldorf-Astoria hotel. The President greets drivers at the hotel.

First Lady Hillary Rodham Clinton greets Kristina Ratia & family, Isabelle Goetz, and Jennifer Palmieri.

Photographs from July 30, 2000 are as follows:

President William Jefferson Clinton stops at a Starbucks in Chappaqua, New York.

President William Jefferson Clinton arrives at Chicago O'Hare International Airport. The President greets Bernard Stone, Loraine Dixon, John Stroger, Louis Lang, and Kevin O'Keefe, among others.

President William Jefferson Clinton addresses a Democratic National Committee Luncheon.

President William Jefferson Clinton addresses the Association of Trial Lawyers of America (ATLA).

President William Jefferson Clinton departs Chicago en route to Andrews Air Force Base.

System of Arrangement
