#### Scope and Content

FOIA 2021-0265-F is a request for all photographs containing Richard Dreyfuss. Richard Dreyfuss is an actor and writer who founded The Dreyfuss Civic Initiative.

Events responsive to this case include an Arts and Humanities program at the White House on April 26, 1996. Present include First Lady Hillary Rodham Clinton, the Chicago Children's Choir, Richard Dreyfuss, William Strickland, Joel Hernandez, Jane Alexander, Sheldon Hackney, John Brademas, Diane Frankel, and Ellen Lovell.

Material responsive to this case was previously processed in FOIA case number 2006-1135-F.

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact

sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
