Scope and Content

FOIA 2021-0647-F is a request for all photographs relating to State Dinners of Japan. The request includes State Dinners held at the White House, and State Dinners for the United States held in Japan. Under the Clinton administration there were two State Dinners for Japan at the White House on June 13, 1994, and May 3, 1999, and one State Dinner for the United States in Japan on April 17, 1996.

Individuals photographed include President William Jefferson Clinton, First Lady Hillary Rodham Clinton, Emperor of Japan Akihito (明仁), Empress of Japan Michiko (美智子), Prime Minister of Japan Keizo Obuchi, Mrs. Chizuko Obuchi, Ambassador Walter Mondale, Joan Mondale, Secretary of Commerce Mickey Kantor, Ambassador Tom Foley, Donna Shalala,

Events responsive include preparation of the Japanese State Dinner at the White House, The President and First Lady giving a tour during the Japanese State Dinner at the White House, The President speaking at entertainment in the South Lawn tent at the White House, The President, First Lady, Prime Minister Obuchi, and Mrs. Obuchi greeting guests at the White House, and The President and First Lady attending a State Dinner at the Imperial Palace in Tokyo, Japan hosted by Emperor Akihito and Empress Michiko. The majority of images in the case are greeting shots at the White House during the State Dinner on May 3, 1999, with most of the guests listed previously in attendance.

Events processed as consequence include presenting a painting of Eleanor Roosevelt at the White House on May 26, 1994, and a departure via Marine One from the Akasaka Place (Government guest house near the Imperial Palace) in Tokyo, Japan on April 17, 1996.

Images responsive to this case were previously processed in FOIA case number 2016-0871-F.

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
